This type of system is proven in the long-run to provide a more accurate tool in fighting and preventing crime.

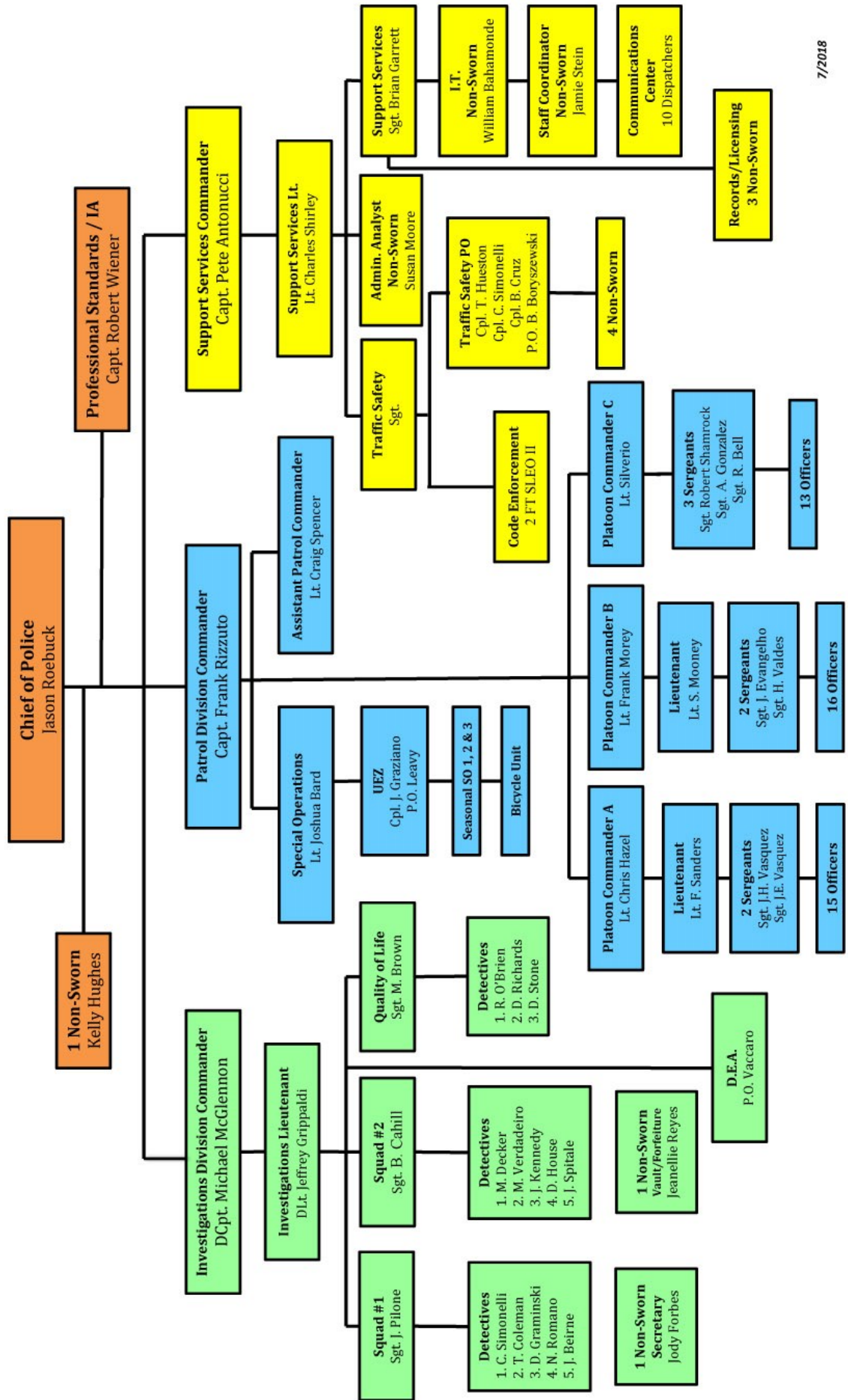

SPECIALIZED UNITS

INVESTIGATIONS BUREAU

The Long Branch Police Department Investigations Division gathers facts for criminal investigations and prosecutions. They compile evidence by observing suspects, interviewing witnesses, and examining physical evidence. The Detectives investigate criminal acts including homicides, sexual assaults, armed robberies, home invasions, and property crimes such as burglaries and arson as well as any unattended deaths. Detectives collect and use forensic evidence to solve crimes, and interview informants, suspects, and witnesses to ascertain alibis, motives, clues, and establish time frames. Detectives spend most of their time gathering facts and evidence for criminal cases they have been assigned. They gather evidence through informants, by interviewing witnesses, and by observing, monitoring, and recording the activities of known or suspected criminals. In performing their duties, it is absolutely necessary that they gain knowledge of suspects and the circumstances surrounding a crime before singling out a perpetrator. Once motives, alibis, past relationships, and the evidence has been determined and analyzed, a detective will interrogate a suspect with the aim of determining their guilt or innocence.

In 2018, a total of 629 cases were investigated by our Detectives.

The Investigations Bureau maintains Units specializing in Major Crimes, Street Crimes, Forensics and Juvenile Matters. Detectives are dedicated to the following areas:

- 14.95 pounds of Marijuana

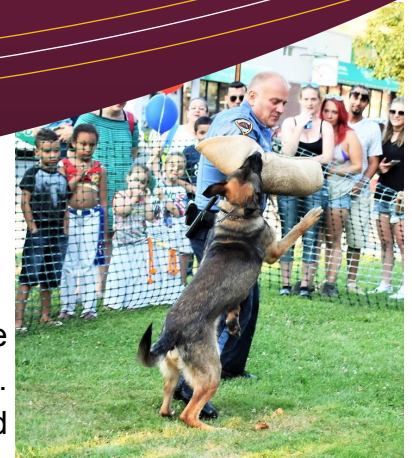


K9 UNIT

The City of Long Branch Police Canine (K9) Unit is made up of two teams, Sgt. Robert Shamrock and K9 Hagan and P.O. Omar Akel and K9 Hades. These teams respond when patrol requests help in cases that that involve expertise in areas such as tracking a suspect and locating narcotics.

On June 12th, 2018 PO Akel & K9 Hades were able to track a locate a suspected burglar when called to the scene from which the suspect had recently fled.

In addition to responding to official service calls, our K9 Unit plays a vital role in our community outreach efforts, participating in numerous demonstrations for our public schools, Citizens Police Academies, National Night Out, and many other events.



URBAN ENTERPRISE UNIT (UEZ)

The Urban Enterprise Zone (U.E.Z.) focuses on our community in an effort to keep the lines of communication flowing between the police department and the public. Corporals Joseph Graziano and Kimberly Leavy work closely with local business owners, students and residents and provide a multitude of events and services throughout the year. A few examples of their programs include school presentations, senior program involvement, City Hall tours for scouts and students, and perhaps the two most popular, National Night Out and the Citizens Police Academy (CPA).



HONOR GUARD

BIKE UNIT

The Police Department's Bicycle Unit is a seasonal component of the Patrol Division. From April to October the primary function of the unit is to patrol areas of the City on bicycle, focusing on areas along the beachfront as well as inner city locations. Being out on a bike allows these Officers to easily interact with other cyclists and pedestrians making them a crucial part of our Community Policing efforts. They also participate in seasonal events to encourage bicycle safety.

The majority of members in the Bike Unit are SLEO I Officers who are trained and overseen by Officers Vecchione and Oliveira.





FIREARMS UNIT

Members of the Firearms Unit include Supervising Firearms Instructor Sgt. John Evangelho, Instructors Sgt. Sam Yoo, Sgt. Hector Umana, Cpl. Ben Cruz, Cpl. Chris Gant, Det. Rich O'Brien and Cpl. Lance Fanning who is also the Armorer.

This unit is tasked with the annual firearms training and qualifications of all LBPD Officers as well as maintaining the weapons and ammunition for the department. In October, the Firearms Unit successfully trained our new rifle operators (top left) in an intense 3-day course.

TRAFFIC BUREAU



Our Traffic Bureau consists of four full-time officers, one Special Class 2 and three civilians. Members include Cpl. Thomas Hueston, Cpl. Cesare Simionelli, Cpl. Benny Cruz, PO Brian Boryszewski, SO Kevin Cuje, George Medina, Andrew Clay and Ryan Scanlon. Lt. Charles Shirley, Jr. is the Unit's Supervisor.



While the Unit was originally formed with the goal of maintaining and repairing traffic signals, the responsibilities of its members have grown to include street signage, special event, road crew and new construction traffic plans, vehicle upgrades and the installation and maintenance of equipment within our vehicles. With ever changing technology, these members are constantly being trained to work on new equipment. Scanlon, our newest member brings an extensive skill set to the unit as he is certified in areas such as programming and installation

of police radios, emergency lights, surveillance cameras, body worn cameras and digital mobile video recorders (DMVR).

ANIMAL CONTROL

On March 1st, 2018, Detective David House was appointed as the Municipal Humane Law Enforcement Officer (HLEO) for the Long Branch Police Department and Officer Francis Sheldrick was appointed as Assistant HLEO. They are tasked with investigating any severe animal cruelty cases within the city.

All our officers assist the City's Animal Control Bureau on a regular basis responding to calls that involve animals in distress or in need of rescuing. From seals on the beach to squirrels trapped drain hole, our officers have seen it all! And yes, all the animals seen in these photos were rescued without injury!



CODE & FIRE PREVENTION



Class 2 Special Officers Brian Dinero and Giovanni Rodriguez are assigned to the City Code & Fire Prevention Bureau.

Along with responding to calls for service as an auxiliary to police patrol units, their primary duty with code enforcement is to ensure property owners comply with the safety and quality of life ordinances. These including property maintenance, fire code compliance, zoning and building permit compliance, and environmental concerns such as recycling and proper waste disposal.

They inspect for hazards to pedestrian and vehicular traffic such as low wires, dangerous trees, dangerous sidewalks, derelict or vacant homes and abandoned swimming pools, and standing water issues for mosquito control. They also investigate illegal rooming houses, unregistered rental properties, conduct inspections for certificate of occupancy compliance, and perform annual "meet and greet" inspections of all off campus housing for Monmouth University to welcome students and insure they comply with local ordinances.

In addition, they set up and maintain the "hot zone" for any fireworks display, and respond to any general emergency in the city, and cover during states of emergencies and special events, as well as coordinate with other agencies such as the EPA/DEP and utility providers for any issues falling outside the scope of routine enforcement.

OUTSIDE AGENCY ROLES

MOCERT

In September of 2018, K9 Team Officer Omar Akel and Hades became members of the Monmouth County Emergency Response Team (MOCERT).

MOCERT is operated by the County Prosecutor's Office and integrates tactically trained officers from numerous municipal police departments to form one team. All members have received advanced training in various fields which include but are not limited to Special Weapons And Tactics, high-risk warrant service, hostage rescue, barricaded suspects, active shooters and dignitary protection. Recent team training has included preparation for weapons of mass destruction and terrorism incidents. The team has trained with FBI SWAT and LAPD SWAT as well as instructors from various military and private organizations.

Members train as a team bi-monthly as well as for several full weeks throughout the year. Officers are on call 24 hours a day and 7 days a week. Semi-annually members undergo rigorous physical tests to remain on the team. In addition, members of the team must maintain the rank of firearms expert through firearms qualification scores."



SCART

Officer Brian Boryszewski, a member of our Traffic Bureau became joined the Monmouth County Serious Collision Analysis Response Team (SCART) in the fall of 2018.

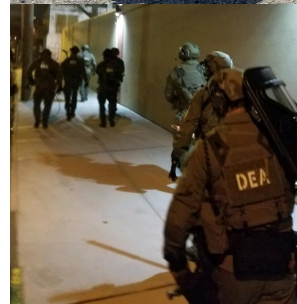
He is on call one week a month and responds to any fatal or serious bodily injury motor vehicle accident in Monmouth county during that timeframe.



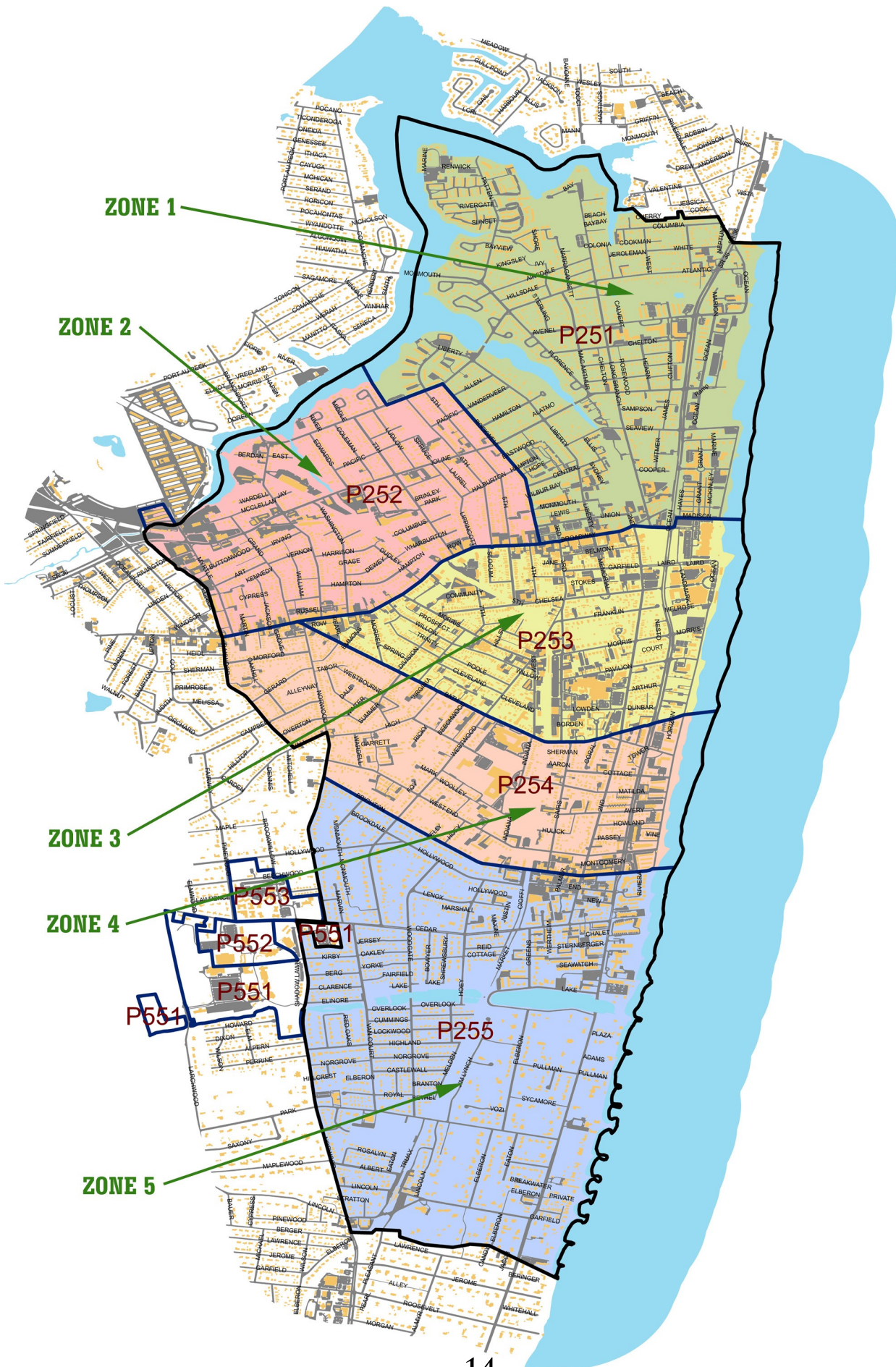
DEA

From July of 2016 until January 2019, Officer Patrick Vaccaro was assigned to the Drug Enforcement Administration (DEA), New Jersey Division, Newark Field Office, Tactical Diversion Squad (TDS), in the capacity of Task Force Officer. In addition to his duties as a member of the TDS task force, he was a member of the, DEA, New Jersey Division, Special Response Team (SRT) and a member of the DEA, New Jersey Clandestine Laboratory (Clan Lab) response team.

During his time as a Deputized Task Force Officer, he conducted and assisted in numerous narcotics investigations across the nation which have led to the arrests and convictions of subjects involved in the illegal trafficking of controlled dangerous substances. He participated in numerous search warrant executions and Wiretap investigations in which large sums of narcotics, money, and weapons were seized.

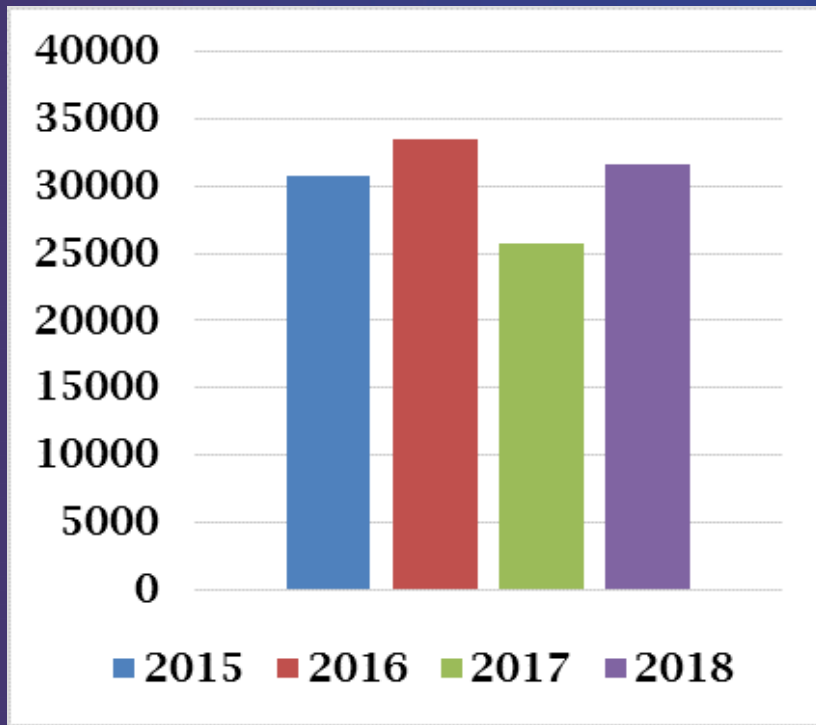


PATROL ZONES

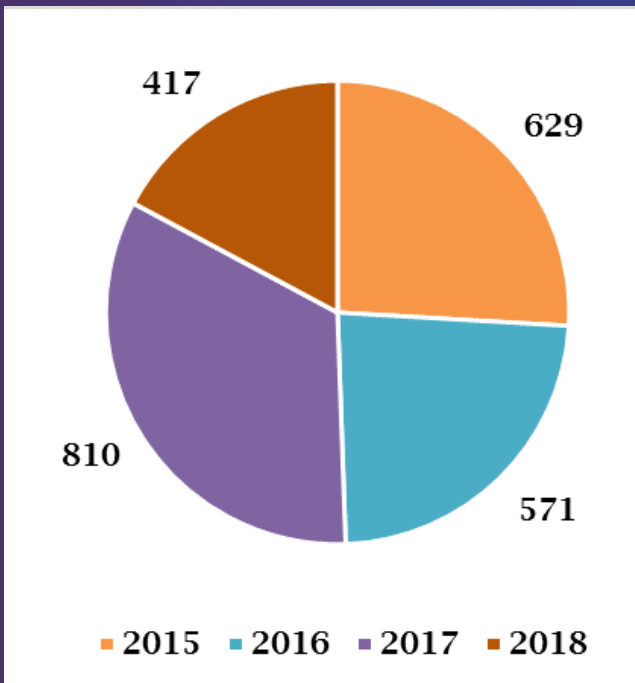


2018 STATISTICS

CALLS FOR SERVICE

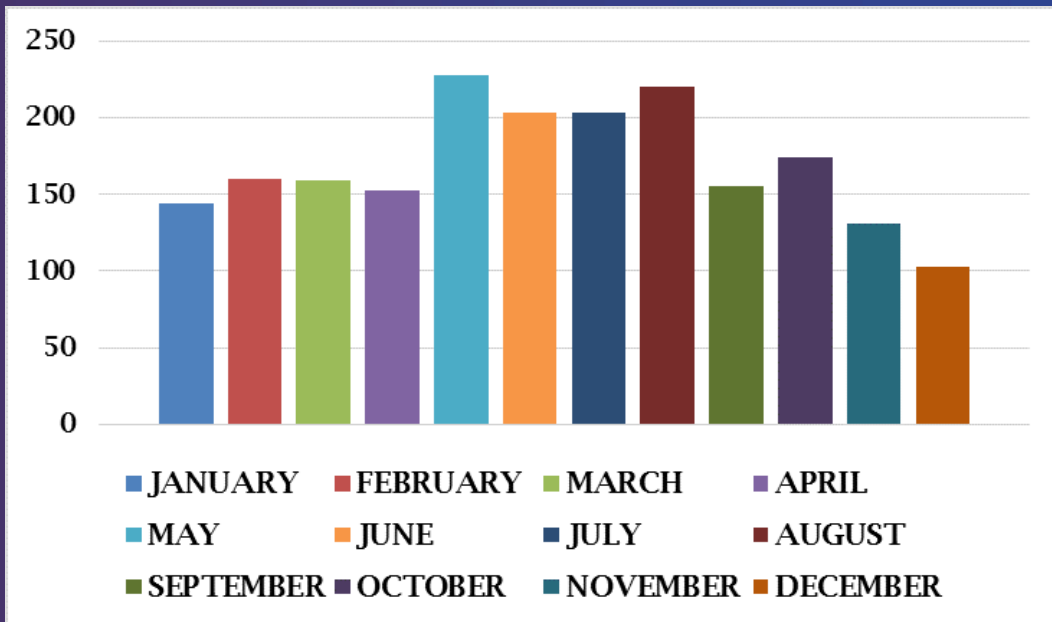


9-1-1 CALLS

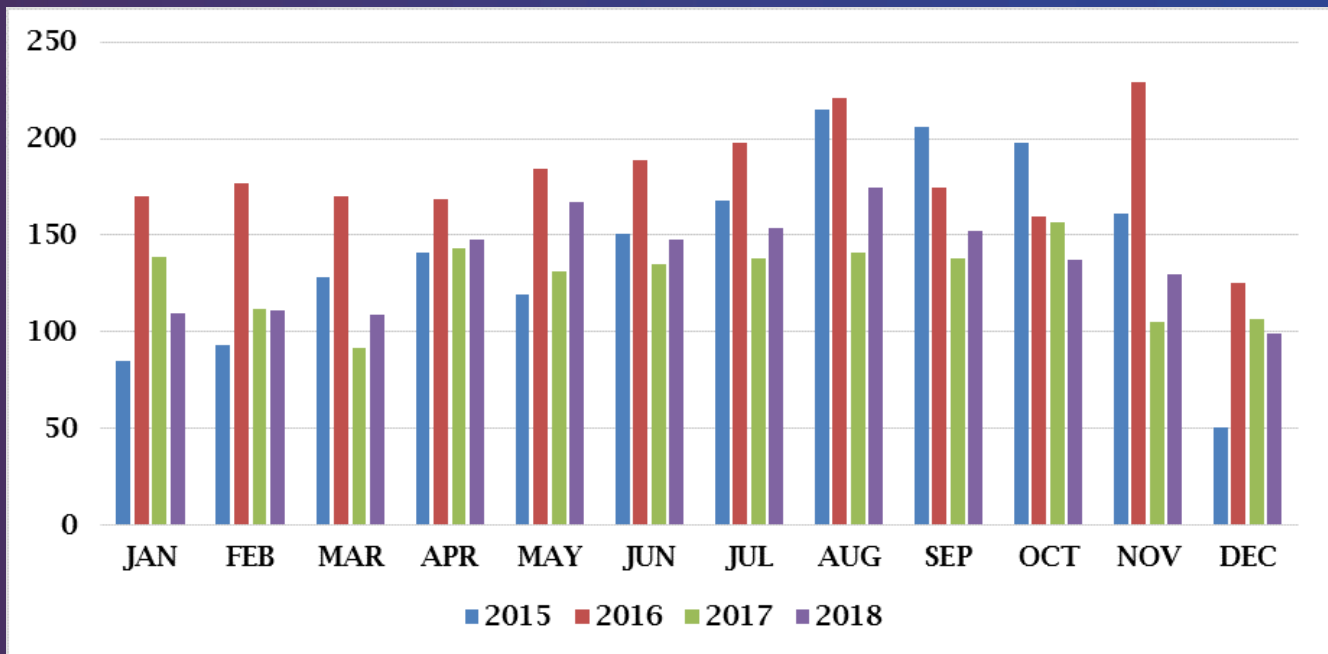

2018 ARRESTS BY MONTH (TOTAL ARRESTS FOR THE YEAR=2,034)



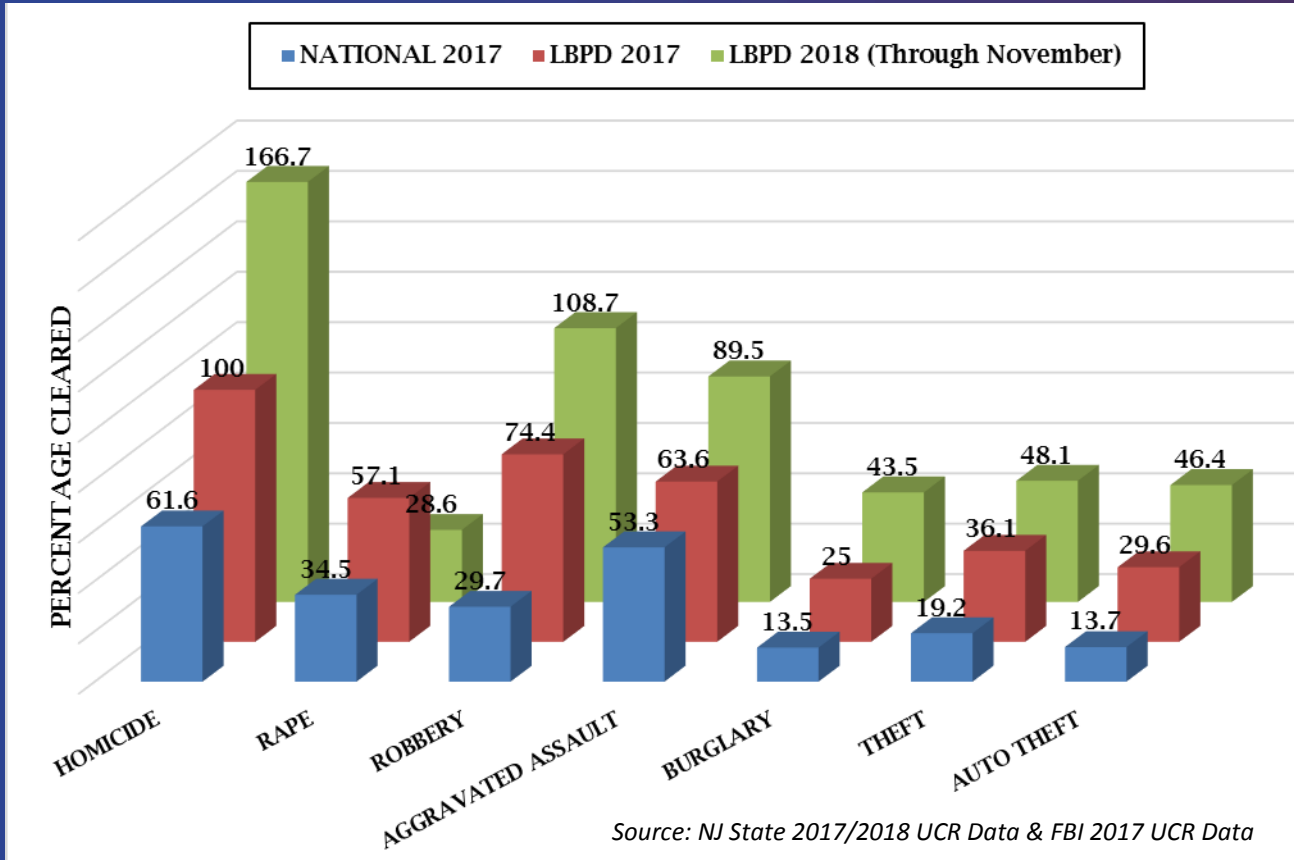
ARRESTS BY MONTH 2015-2018

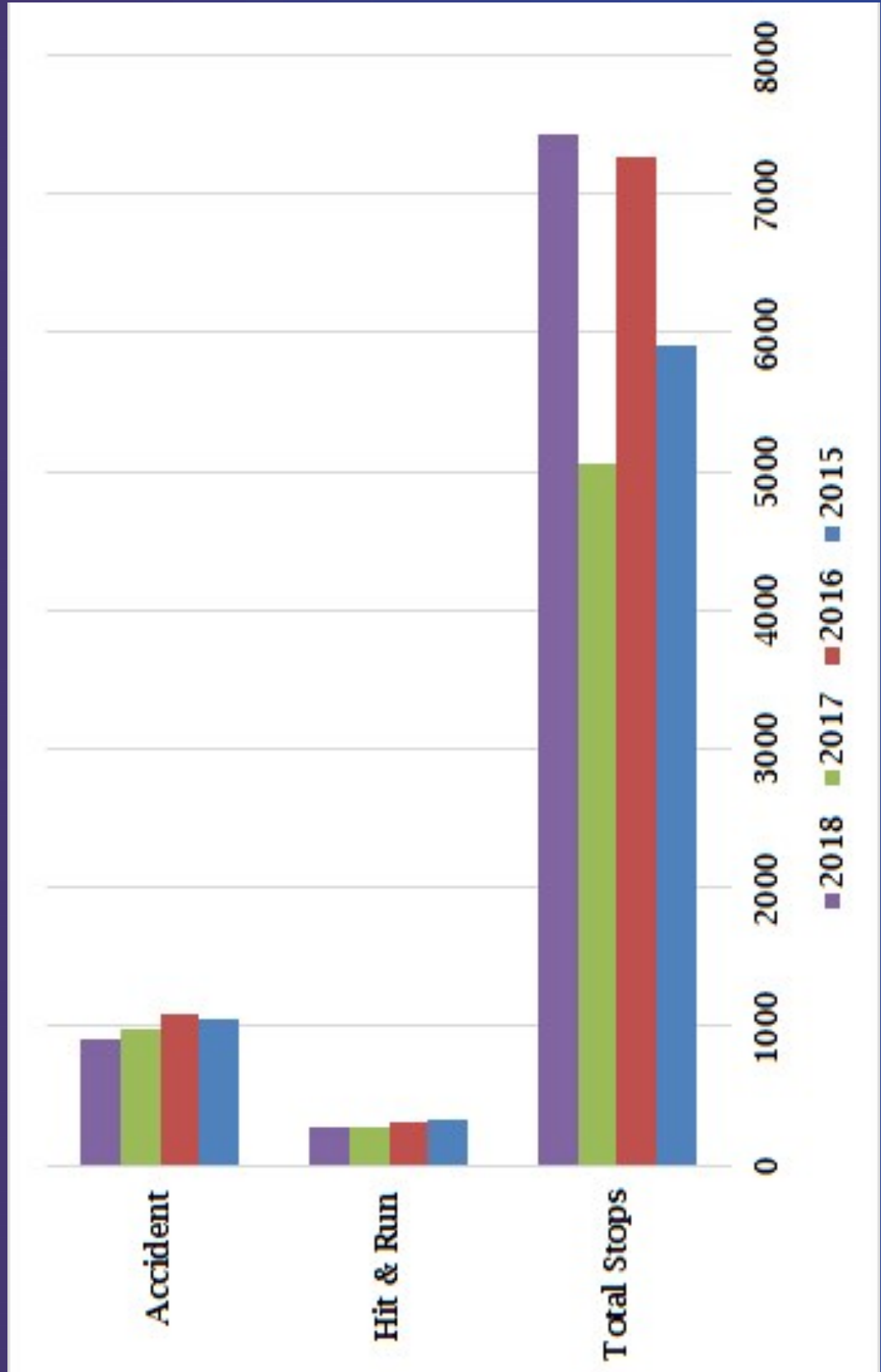
Law enforcement agencies must meet the following four conditions in order to clear an offense by exceptional means:

- Identified the offender.
- Gathered enough evidence to support an arrest, make a charge, and turn over the offender to the court for prosecution.
- Identified the offender's exact location.
- Encountered a circumstance outside the control of law enforcement that prohibits the agency from arresting, charging, and prosecuting the offender.

Examples of exceptional clearances include, but are not limited to, the death of the offender or the victim's refusal to cooperate with the prosecution after the offender has been identified.

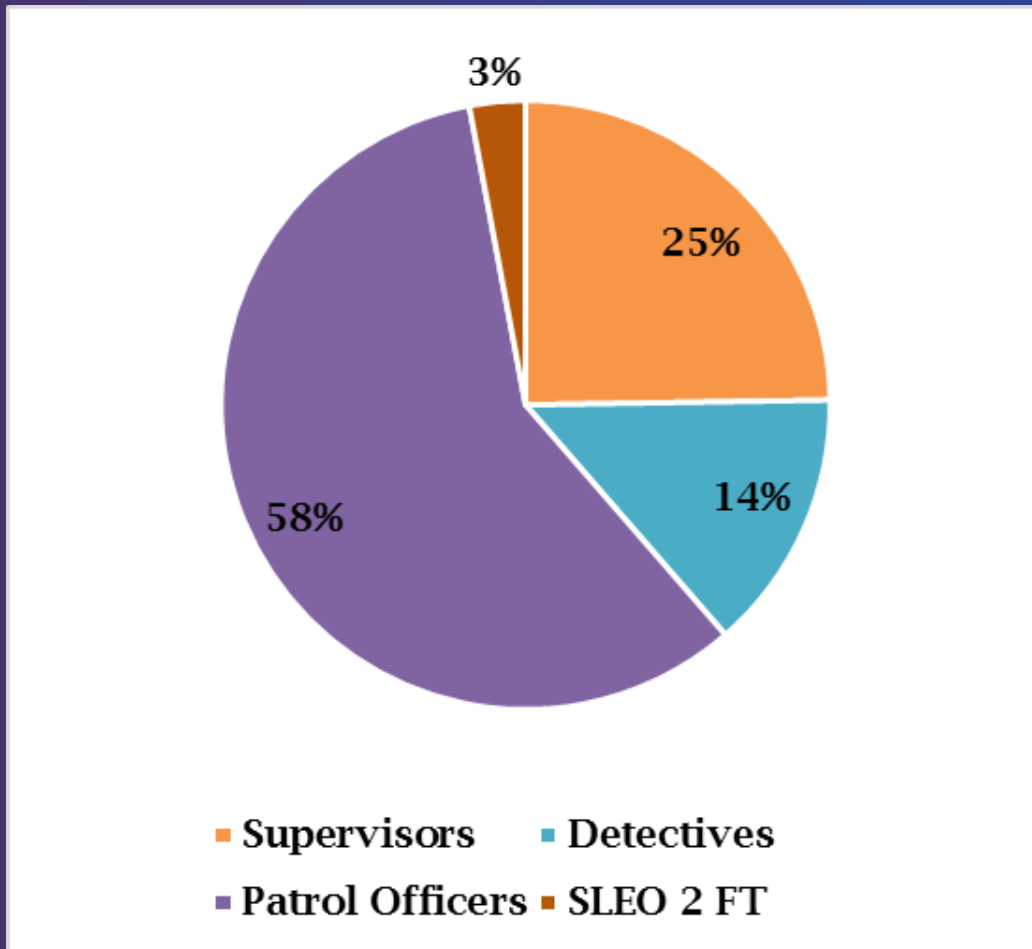

FULL TIME SWORN OFFICERS



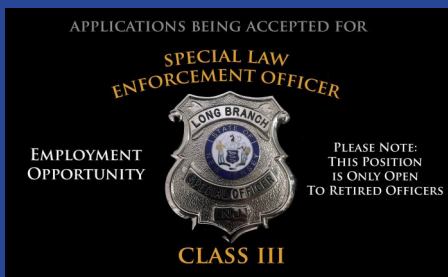

OPERATIONAL ADVANCES

CLASS 3 OFFICERS

The City of Long Branch Police Department in conjunction with Long Branch Public Schools implemented the "NEW" position of Class III Special Law Enforcement Officers (SLEO 3) in 2018. The position requires applicants to be Retired Law Enforcement Officers and was created to provide additional school security to students and staff during school hours as well as after-school activities.



COMPSTAT

The department began to hold Comparative Statistics (CompStat) meetings in February of this year.

CompStat offers a dynamic approach to crime reduction, quality of life improvement, and personnel and resource management, whereby ranking police department executives identify spikes in crimes using comparative statistics and address those spikes through the use of targeted enforcement.

The command staff discusses current crimes and cases, recent crime trends, case management, statistics, and enforcement ideas to address any spikes in a certain crime or area. Heat maps of the zones and criminal activity are used to pinpoint crime trends and the time of the day and week that it is likely to happen.

CompStat has the added benefit of allowing the staff to meet regularly (with shift work, that can be difficult to organize) and talk about issues in a timely manner. Information can flow both downward and upward, and a face-to-face meeting allows questions to be asked and answered. All of this allows the Patrol, Investigations and Support Divisions to be on the "same page", which is vitally important. The Patrol Division will also hold a divisional staff meeting prior to the department meeting, allowing the day time Patrol staff to interact with the Platoon Commanders who may be working the afternoon and evening/overnight shift.

Thank you to North Bergen Police Department for having us up to see their CompStat program and sharing the format with us.

FOOT POSTS

In September, LBPD introduced a new community policing plan of increased foot patrols in the City's business districts.

State Urban Enterprise Zone (UEZ) funds originally supplemented the salaries of four officers to walk foot patrol but the state cut the program from four officers to one. Chief Roebuck worked with Mayor Pallone to develop new measures that allowed UEZ officers to increase foot time after the summer season and to assign another officer to the UEZ unit.



The increased foot patrols take place both Uptown and Downtown Broadway, along the Third Avenue business district, in West End and at Pier Village.

Each officer is expected to complete a foot patrol in their zone's business district on a daily basis (weather dependent) in addition to day shift's school patrols.

POLICE CHAPLAINS

DSgt. Brendan Cahill served as PD Chaplains Coordinator in 2018.

Ordinance R184-17 appointed 10 Clergy Members as Police Chaplains for a period of 2 years. The group met in January of 2018 to share ideas and formulate their goals. Based on interest from that meeting, in July, LBPD hosted a Basic Police Chaplain Training Program, presented by Gary Holden for which 13 Clergy Members attended.

The Chaplains in this program are willing to minister to all faiths and to assist with death notifications, crisis situations, etc. We are very grateful to the members of this program for their desire and willingness to serve our officers and local community!



TRAINING



All Officers are required to attend in-service training sessions to stay up-to-date on current laws, professional guidelines, operations and procedures. Some of the training is department specific, while much of it is mandated by the county prosecutor, Attorney General and by state or federal statutes. Most mandated training is required every six months to one year. A few topics covered in the training are firearms requalification, domestic violence, blood-borne pathogens, hazardous materials and breathalyzer recertification.

Specialized units conduct job-specific training and qualification sessions and officers are assigned to attend other agency training courses as needed. The list on the following page shows just a fraction of the training courses that our officers attended in 2018. On average, nearly 400 training orders are issued to individual Officers per year.

In addition to classroom training, hands-on training exercises are conducted by members of our department including firearms, active shooter drills and other response scenarios, such as November's 3 hour train derailment drill conducted by the NJ Transit.

JANUARY 1, 2018—FOUR DEAD FOLLOWING SHOOTING INSIDE LONG BRANCH HOME

A 16-year-old boy is in police custody after four people were found shot to death inside his parent's Long Branch home, announced Monmouth County Prosecutor Christopher J. Gramiccioni.

Long Branch police responded to a 911 call reporting shots fired at 635 Wall Street in the city at 11:43 p.m. on Sunday, Dec. 31, 2017.

Long Branch police and Monmouth County Sheriff's Office arrived on scene a minute later where they discovered four deceased victims: the suspect's father, Steven Kologi, 44; mother Linda Kologi, 42; sister Brittany Kologi, 18; and family acquaintance, Mary Schultz, 70, of Oakhurst Parkway in Ocean Township.

A joint investigation by the Monmouth County Prosecutor's Office and Long Branch Police Department continues, but it appears the 16-year-old boy used a Century Arms semi-automatic rifle to kill his victims. The teenager was taken into custody without incident.

JANUARY 8, 2018 - OCEAN COUNTY MAN INDICTED FOR OCTOBER SHOOTING

Donovan Wesley, 25, of Brick Township, is charged with one count each of second degree Armed Burglary, first degree Attempted Murder, second degree Possession of a Weapon for an Unlawful Purpose and first degree Unlawful Possession of a Weapon.

The charges stem from a Sunday, October 8, 2017, shooting inside a residence on West Columbus Place in Long Branch. The Long Branch Police Department responded to a 911 call at about 1:50 a.m. reporting shots fired at that location. Police arrived to find the victim, a 31-year-old male, suffering from multiple gunshot wounds. He was transported to Jersey Shore University Medical Center, Neptune Township, by Long Branch EMS and MONOC paramedics, where he was treated for his injuries and released a few days later.

A joint investigation by the Monmouth County Prosecutor's Office and the Long Branch Police Department revealed Wesley shot the victim after the two men got into a verbal disagreement earlier in the evening. Wesley then arrived at the victim's home and confronted the victim before shooting him during a brief struggle.

If convicted of Armed Burglary, Wesley faces a sentence of five to ten years in prison. If convicted of Attempted Murder, Wesley faces up to 20 years in a New Jersey state prison. Both charges are subject to the provisions of the "No Early Release Act" (NERA) requiring him to serve 85 percent of the sentence imposed before becoming eligible for release on parole. He would also be under parole supervision for five years following his release from state prison. If convicted of Attempted Murder, he would be under parole supervision for three years following his release if convicted of Armed Burglary.

If convicted of Possession of Weapon for an Unlawful purpose, he faces a sentence of five to ten years in prison. If convicted of Unlawful Possession of a Handgun, Wesley faces five to ten years in state prison. Each of those charges is subject to the Graves Act mandatory period of parole ineligibility of up to one half of the custodial sentence imposed.

JULY 19, 2018—SEARCH OF HOME NETS \$50K IN COCAINE, \$32K IN CASH, 3 VEHICLES

An investigation started earlier this year culminated Wednesday afternoon with the arrest of Long Branch man accused of distributing cocaine in the Long Branch area, announced Monmouth County Prosecutor Christopher J. Gramiccioni.

Giddel Gonzalez Estrada, who will celebrate his 37th birthday on Tuesday, of Broadway, was arrested inside a Morris Avenue garage Wednesday afternoon and charged with first degree Possession of Cocaine with Intent to Distribute (over 5 ounces), second degree Possession of a Weapon While in the Course of Committing CDS Offense, 42 counts of combined third degree charges including Possession of Cocaine, Distribution of Cocaine, Possession of a Controlled Dangerous Substance with Intent to Distribute, Possession of a Controlled Dangerous Substance within 1,000 feet of a School Zone.

Detectives from the Monmouth County Prosecutor's Office Gang and Criminal Enterprise Unit and its Narcotics Strike Force executed search warrants at an apartment at 494 Broadway, and 407 Morris Avenue, both in Long Branch. Seized at the two locations were three vehicles, about \$32,000 in cash, approximately 500 grams of cocaine with a street value of about \$50,000, a small amount of marijuana, a .22 cal. handgun, and large amounts of packaging, weighing materials and various paraphernalia used for the sale and distribution of illegal narcotics.

If convicted of first degree Possession of Cocaine with Intent to Distribute (over 5 ounces), Estrada faces up to 20 years in a New Jersey state prison. If convicted of any of the second degree charges, he faces a sentence of five to ten years in prison on each count. If convicted of any of the third degree offense, Estrada faces a sentence of three to five years in prison.

AUGUST 9, 2018—LONG BRANCH MAN CHARGED IN APRIL ROBBERY, SHOOTING

A Long Branch man is charged in connection with an April 16, 2018 attempted murder and robbery in Long Branch, announced Monmouth County Prosecutor Christopher J. Gramiccioni.

Azeem Jackson, 18, of Long Branch, was charged on Tuesday August 7, 2018 with first degree Attempted Murder, first degree Robbery, second degree Possession of a Weapon for an Unlawful Purpose and second degree Unlawful Possession of a Weapon.

A joint investigation by the Monmouth County Prosecutor's Office and the Long Branch Police Department began after officers were dispatched to the scene of a report of a gunshot victim, located at the corner of Matilda and Second streets. The victim was taken to Jersey Shore Medical University Hospital and treated for a gunshot wound to the chest. Based upon the investigation, detectives were able to identify Azeem Jackson as the individual who shot the victim during the robbery attempt.

If convicted of Attempted Murder, Jackson faces 20 years in a New Jersey state prison without parole, subject to the provisions of the "No Early Release Act" (NERA) requiring him to serve 85 percent of the sentence imposed before becoming eligible for release on parole. He would also be under parole supervision for five years following his release from state prison. If convicted of Robbery, Jackson faces a maximum of 20 years in prison, which is also subject to NERA.

If convicted of the second degree weapons offenses, Jackson faces a maximum sentence of 10 years in a New Jersey state prison on each count, subject to the provisions of the Graves Act, which carries a mandatory period of parole ineligibility of one half of the custodial sentence imposed, or 42 months, whichever is greater.

NOVEMBER 14, 2018—LONG BRANCH MAN INDICTED FOR MURDER IN FATAL SHOOTING

A Monmouth County grand jury has returned an eight-count indictment charging a Long Branch man with the August fatal shooting of 45-year-old Marco Moreira and the attempted murder of Fernanda Silva inside the Bom DMais restaurant located at 545 Broadway, announced Monmouth County Prosecutor Christopher J. Gramiccioni.

Miguel L. Camara, 40, of Chelsea Avenue in Long Branch, is charged in the indictment handed up Wednesday with first degree Murder, first degree Attempted Murder, second degree Possession of a Weapon for an Unlawful Purpose, second degree Unlawful Possession of a Weapon, fourth degree Aggravated Assault by Pointing a Firearm, second degree Disarming a Law Enforcement Officer, third degree Endangering the Welfare of a Child, and fourth degree Contempt.

On August 21, 2018 at approximately 3:15 p.m., Long Branch Police Officer George Samol was flagged down by a motorist on Broadway who reported a fight inside the Bom DMais restaurant and a shot fired through the front window. Officer Samol responded to the restaurant and observed two males and one female wrestling with Camara who was holding a gun. Officer Samol unholstered his duty weapon and ordered Camara to drop the weapon. As the 18 year old son of Fernanda Silva was able to gain control over Camara's gun, Camara immediately turned to Officer Samol and grabbed ahold of his duty weapon, trying to take possession of it. Officer Samol was able to wrestle the gun from Camara as additional officers arrived on scene. After Camara was placed under arrest, officers observed the victim, Marco Moreira lying deceased on the floor of the business. He was pronounced dead at 3:38 p.m.

A joint investigation by the Monmouth County Prosecutor's Office and the Long Branch Police Department determined Camara entered the Bom DMais restaurant and approached the table where his ex-girlfriend Fernanda Silva, her two children ages 18 and 5, and Marco Moreira were seated. Camara threw a court document on the table, pulled out a handgun and pointed it at Marco Moreira's head several times before shooting him. A struggle then ensued between Silva, her 18 year old son and Camara for the gun. During the struggle Camara repeatedly pointed the gun at Silva, firing it twice but missing her. Silva's five year old daughter was a few feet away during the struggle.

If convicted of Murder, Camara faces a minimum sentence of 30 years in a New Jersey state prison without parole and a maximum sentence of life imprisonment, subject to the provisions of the "No Early Release Act" (NERA) requiring him to serve 85 percent of the sentence imposed before becoming eligible for release on parole. He would also be under parole supervision for five years following his release from state prison.

If convicted of Attempted Murder, Camara faces a sentence of up to 20 years in a state prison, also subject to the provisions of the NERA. If convicted of Disarming a Law Enforcement Officer, Camara faces up to 10 years state prison, also subject to the provisions of the NERA.

If convicted of the second degree weapons offenses, Camara faces a sentence of five to ten years in prison, and pursuant to the "Graves Act" there is a mandatory period of parole ineligibility of one half of the custodial sentence imposed, or 42 months, whichever is greater. If convicted of the fourth degree Aggravated Assault by Pointing a Firearm, Camara faces up to 18 months in state prison and pursuant to the "Graves Act" there is a mandatory period of parole ineligibility of 18 months. If convicted of the third degree Endangering the Welfare of a Child, Camara faces up to five years in state prison. If convicted of the fourth degree Contempt, Camara faces up to 18 months in state prison.

NOVEMBER 15, 2018—NEPTUNE MAN INDICTED FOR DEALING DEADLY DRUGS

A Monmouth County Grand Jury handed up a four count Indictment Wednesday, charging a Neptune man with selling drugs that led to the overdose death of a Long Branch resident back in May, announced Monmouth County Prosecutor Christopher J. Gramiccioni.

Jomell C. Brathwaite, 36, of Neptune, is charged with first degree Strict Liability for Drug Induced Deaths, third degree Distribution of a Controlled Dangerous Substance, third degree Possession of a Controlled Dangerous Substance and third degree Possession of a Controlled Dangerous Substance with Intent to Distribute, in connection with the sale of a heroin and fentanyl concoction that led to the overdose death of a 49-year old female from Long Branch.

Brathwaite was already being lodged in the Monmouth County Correctional Institution on other charges not pertaining to this incident.

Brathwaite's victim was found by her boyfriend deceased on the morning of May 15, 2018.

The postmortem examination conducted by the Middlesex County Medical Examiner's Office indicated that the cause of the victim's death was "Acute Fentanyl and Heroin Toxicity."

An investigation was launched into the death of the victim by the Monmouth County Prosecutor's Office and the Long Branch Police Department. The investigation determined that Brathwaite had sold the lethal substance during the evening of May 14, 2018, at a local business located in Ocean Township.

If convicted of first degree Strict Liability for Drug Induced Deaths, Brathwaite faces a maximum sentence of life imprisonment in a New Jersey state prison without parole.

If convicted of third degree charges, each crime carries a maximum sentence of five years imprisonment.

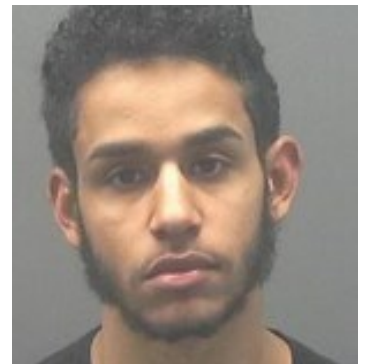
NOVEMBER 26, 2018— SUSPECT IN LONG BRANCH SHOOTING CAUGHT

An 18-year old male suspect has been apprehended in connection with the shooting of an 18-year old Neptune City man that occurred on November 15th, announced Monmouth County Prosecutor Christopher J. Gramiccioni.

Marc Zayas, 18, of Long Branch, was arrested Monday, November 19th following an intense manhunt. Zayas has been charged with Attempted Murder, Possession of a Weapon for Unlawful Purpose and Unlawful Possession of a Weapon.

Long Branch Police responded to a call around 12:01 p.m. on the afternoon of Thursday November 15th, for shots fired in the vicinity of 63 Morris Avenue. Police arrived to find an 18-year old male victim suffering from a gunshot to the back. The victim was taken to a local hospital where he is still currently in critical, but stable condition.

A joint investigation was immediately launched by the Monmouth County Prosecutor's Office and the Long Branch Police Department. As a result of the investigation, Zayas has been charged with the above listed offenses.



DECEMBER 3, 2018—LONG BRANCH MAN INDICTED IN MURDER OF TEENAGE GIRL

A Monmouth County grand jury has returned a five count indictment charging a Long Branch man with the fatal stabbing of 16-year-old Madison Wells in Long Branch, announced Monmouth County Prosecutor Christopher J. Gramiccioni.

Bryan Cordero-Castro, 20, of 4th Avenue in Long Branch, is charged in the indictment handed up Monday with first degree Murder, third degree Possession of a Weapon for an Unlawful Purpose, fourth degree Unlawful Possession of a Weapon, third degree Attempted Escape and fourth degree Stalking.

On September 8, 2018 at approximately 10:42 p.m., a 911 call was placed reporting a stabbing victim in need of medical attention at a Van Pelt Place residence within the city of Long Branch. Long Branch officers and EMS were dispatched to the home where they found a 16-year-old female, Madison Wells, on the living room floor with stab wounds to her chest. She was transported to Monmouth Medical Center where she was pronounced dead at 11:25 pm.

A joint investigation by the Monmouth County Prosecutor's Office and the Long Branch Police Department determined that Cordero-Castro and Madison began dating in November 2017. Madison recently ended the relationship resulting in Cordero-Castro texting and calling her numerous times in the 9 hour period leading up to the murder. Cordero-Castro ultimately located the victim at the Van Pelt Place residence where Madison agreed to go outside and speak to him. A few minutes after going outside, Madison stumbled back into the house and collapsed on the floor from the stab wounds to her chest.

Cordero-Castro was arrested at his cousin's residence on Morris Avenue in Long Branch approximately 2 hours after the murder. Once at The Long Branch Police Department, Cordero-Castro attempted to escape by jumping up and trying to run out of the booking room. He was quickly stopped by Detective Sergeant Brendan Cahill and Officer Evan Morell, both of the Long Branch Police Department.

If convicted of Murder, Cordero-Castro faces a minimum sentence of 30 years in a New Jersey state prison without parole and a maximum sentence of life imprisonment, subject to the provisions of the "No Early Release Act" (NERA) requiring him to serve 85 percent of the sentence imposed before becoming eligible for release on parole. He would also be under parole supervision for 5 years following his release from state prison.

If convicted of the third degree charges of Possession of a Weapon for an Unlawful Purpose and Attempted Escape, Cordero-Castro faces a sentence of three to 5 years in prison on each of those charges. If convicted of the fourth degree charges of Unlawful Possession of a Weapon and Stalking, Cordero-Castro faces up to 18 months in prison on each charge.



DECEMBER 17, 2018—LONG BRANCH MAN NOW CONVICTED OF LIQUOR STORE ROBBERY HAD 10 PRIOR CONVICTIONS

A Monmouth County jury convicted a Long Branch man of a 2017 liquor store robbery and he now faces an extended prison term due to his prior convictions, announced Prosecutor Christopher J. Gramiccioni.

John Vernicek, 38 of Long Branch, was convicted Thursday of one count each of second-degree Robbery and third-degree theft following a two-week trial before Monmouth County Superior Court Judge Oxley. As a result of his prior record, which includes approximately 10 prior indictable convictions and multiple violent crimes, Vernicek qualifies for a mandatory extended-term sentence. He faces 10-20 years in prison subject to the No Early Release Act when he returns for sentencing on Feb. 8, 2019.

During the course of the trial, jurors learned Vernicek entered Falvo's Liquors in Long Branch on July 9, 2017, where he attacked a store employee and stole money from the register. The victim did not know Vernicek and the crime happened so quickly, she was unable to provide a detailed description of her attacker. During the investigation by detectives from the Ocean Township Police Department surveillance video was obtained from Falvo's and surrounding businesses did provide evidence of a distinctive white van that brought Vernicek to the robbery. Police eventually located the van and its owner, who happened to be a registered sex offender and former drug addict. The man provided detectives with a pair of gloves Vernicek wore during the robbery. The gloves were sent to the New Jersey State Police Forensics Laboratory where forensic scientists found Vernicek's DNA inside the gloves.

Prior to this most recent conviction, Vernicek had been convicted on charges that included burglary, theft, aggravated assault, drug possession, resisting arrest and other indictable charges.

Monmouth County Assistant Prosecutor Joseph Cummings handled the trial for the State.

DECEMBER 18, 2018—MAN FACING LIFE IN PRISON FOR 2013 DOUBLE MURDER

A Monmouth County jury has convicted a Long Branch man for the 2013 double murder of a couple found dead inside a Sairs Avenue apartment and he now faces a mandatory sentence of life imprisonment without the possibility of parole, announced Monmouth County Prosecutor Christopher J. Gramiccioni.

Carlos I. Menjivar, 26, of 45 North Fifth Ave. in Long Branch, was found guilty of murder and weapons offenses for the Mar. 24, 2013 slayings of Maria Yolanda Catejo-Munoz, 35, and Fredis Orlando Ventura, 33, both of Long Branch. The guilty verdict of two counts of first-degree Murder, one count each of third-degree Possession of a Weapon for an Unlawful Purpose and fourth-degree Unlawful Possession of a Weapon comes after a 2-month trial before Monmouth County Superior Court Judge David F. Bauman. Menjivar faces a mandatory sentence of life imprisonment without the possibility of parole when he returns for sentencing on Feb. 1, 2019.

Menjivar was arrested following a joint investigation by the Monmouth County Prosecutor's Office Major Crimes Bureau, Long Branch Police Department and Monmouth County Sheriff's Office. The investigation began after Catejo-Munoz was reported missing around noon on Sunday, March 24, prompting a search for her whereabouts. The search led Long Branch Police to the Sairs Avenue apartment of Ventura, who had been romantically involved with Catejo-Munoz. At around 4 p.m. on Mar. 25, 2013, both victims were discovered dead inside the apartment with multiple stab wounds.

Evidence presented at the trial revealed that Ventura invited Menjivar, a third man and Catejo-Munoz to his residence in the early morning hours of Mar. 24, 2013. After the third man had left the apartment, Menjivar fatally stabbed the two victims.

During the investigation, police learned Menjivar had been in possession of a knife while inside Ventura's apartment and had asked the other man there not to tell the police about the knife. Approximately 21 months later, on Dec. 16, 2014, Menjivar admitted to detectives that he stabbed Ventura in the neck with a knife, but claimed he had been forced to do so by others who had also killed Catejo-Munoz. DNA, forensic evidence located at the crime scene and his own phone records disproved Menjivar's version of events.





FROM THE OFFICE OF THE POLICE CHIEF

JANUARY 21, 2018

Glad to see our new officers are jumping right in...protecting and serving both on duty and off!

On January 20th, 2018 at approximately 10 pm, newly hired Police Officer Daniel Cunha was driving his personal vehicle on Cedar Avenue, when he observed and heard an argument on the corner of Cedar and Ocean Ave. The participants were screaming in Portuguese, and Cunha is fluent in Portuguese. He saw them attempting to hold a male subject back from appearing to assault a female. They were screaming in Portuguese for him to calm down.

Officer Cunha pulled his vehicle over and took action, identifying himself as a Police Officer and approaching the incident. A quick interview confirmed the male subject was intoxicated and attempting to assault his girlfriend. Cunha was attempting to use his cell phone to call headquarters, when the subject, later identified as Matheus Tavares Emidio, charged Cunha screaming that it didn't matter that he was a cop. Emidio began to assault Cunha, as Cunha attempted to block his blows while he finished calling headquarters. Eventually, Cunha put his phone away and took Emidio to the ground, holding him there until CPL Robert Korn arrived. Someone else had called 911 while the incident was ongoing, reporting a fight. Korn, unaware that it was Cunha on top of Emidio, pulled him off. Emidio took this opportunity to flee the area on foot.

A foot pursuit ensued, with Emidio losing the officers in the backyards of the houses along 2nd Avenue. Cunha assisted Korn in interviewing the victims, and they learned that Emidio lives in Pleasure Bay Apartments. Officer Chris Gant responded to the area, and located Emidio on the north side of the complex, and ordered him to stop. Emidio fled again, and Gant was joined by another rookie Officer, Conor Mullan and his Field Training Officer, David Stone. Mullan caught Emidio as he ran on the water behind Pleasure Bay, and took him to the ground on the ice about 5 feet onto the frozen river. Emidio continued to fight, attempting to bite Mullan's left ear and grab his face. Mullan was joined by Gant and Stone and was placed under arrest.

Officer's Mullan and Stone suffered abrasions and to their hands and knees and some cuts to their uniforms, and Cunha was brought to Monmouth Medical for a cut on his hand. He landed on a rock when he took Emidio to the ground in the initial incident.

Mathues Tavares Emidio was charged with 3 counts of Aggravated Assault on a Police Officer, and 2 counts of resisting arrest, and a \$350 warrant out of Long Branch. He was transported to the Monmouth County Correctional Institution. US Immigration and Customs Enforcement was also notified and a detainer has been sent to the jail. Emidio is 21 years of age, single, and was residing in Pleasure Bay.

JUNE 13, 2018

On Tuesday, June 12, 2018 at approximately 11:00 PM, a call was placed to LBPD reporting an attempted burglary in progress on Sixth Avenue.

Officer Omar Akel and K9 partner, Hades responded to the scene where the caller was able to give a general direction of travel for the suspect who had just fled. Hades is trained in narcotics detection as well as patrol work and is capable of tracking the freshest odor which has travelled through an area.

Officer Akel and Hades began to track the suspect and almost immediately, K9 Hades had indicated that he knew where the suspect was hiding. He led Officer Akel to an area with thick vegetation. Officer Akel announced himself and warned the suspect that his K9 partner was also present. Shortly after Akel asked the suspect to show himself and a male subject, fitting the description of the accused, surrendered and emerged from the vegetation with his hands up.

The suspect, identified as Ernest Mears of Long Branch, was arrested and charged with attempted Burglary and transported to Monmouth County Correctional Institution.

Officer Akel & K9 Hades are commended for their actions and outstanding teamwork in bringing the suspect swiftly to justice.

JUNE 28, 2018

At approximately 9pm on June 27th, 2018 there was a carjacking in the City of Long Branch, on Norwood Avenue, near Park Avenue. A black male subject approached the victim and asked for directions. The victim's vehicle, a 2017 Infinity QX6, was running in the driveway, and the accused approached the vehicle. The victim moved to cut him off from entering the vehicle, and the accused lifted his sweatshirt to display a black semi-automatic handgun. The victim wisely backed away, and the accused took the vehicle.

The accused drove the Infinity into Ocean Township at a high rate of speed, and subsequently crashed the vehicle. The accused then fled on foot, and a perimeter was set up by Ocean Township, Long Branch and Monmouth County Sheriff's Department. K9 Hades and his handler Officer Akel were called to the scene, and the Monmouth County drone was launched, but to no avail, the accused could not be located.

The vehicle was towed for forensic processing. Anyone with information regarding this case please call the Long Branch Police (732-222-1000) and ask for Detective Verdadeiro. At this point, we are unsure if there is a nexus to the recent rash of high end vehicle burglaries in the Elberon and Deal areas, which were all left unlocked with the key fobs left inside. The Long Branch Police still urge you to lock your doors and take your keys inside.

This program is a very powerful and large-scale presentation that is made possible through the partnering of the Long Branch Public Schools with many local and state agencies. The L.B.P.D., along with the Long Branch Fire Department, Long Branch First Aid, Monmouth County Sheriff's Office, New Jersey State Police, MONOC and other local organizations and businesses all assisted.



OPERATION COPS CARE



In November, the Monmouth County Prosecutor's Office announced the launch of "Operation Cops Care", a unique initiative that LBPD was happy to partner with.

Police officers are often at a loss to know how to help kids who are caught in the middle of police responses to their homes or when kids are brought to the station-house, accompanying their caregivers who need police assistance.

Operation Cops Care provides our police officers with something tangible to give to children who are, for whatever reason, the innocent bystanders to an ongoing police response.

5,000 nylon draw string bags paid for by victim witness grant funding, were filled with teddy bears, coloring books and crayons, stress balls and water bottles for officers to keep in their patrol vehicles.

The idea being that when officers encounter kids who are caught in the middle of some type of police response, call for service, or for kids who are brought to a police department for whatever reason, there will be something that officers already have on hand for those kids, so they won't be as scared and will have something that is just for them and include an activity.

NATIONAL RX TAKE BACK DAY

With a slogan of "Don't Be The Dealer!", LBPD participated once again in the Drug Enforcement Administration's (DEA) National Rx Take Back Day on Saturday, April 28th.

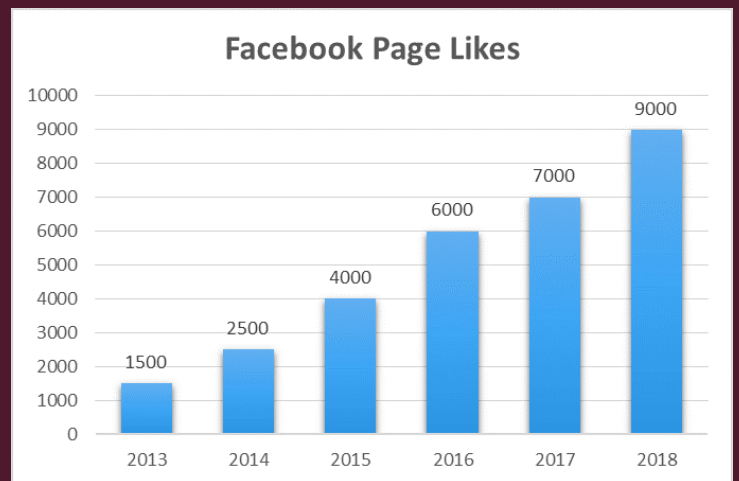
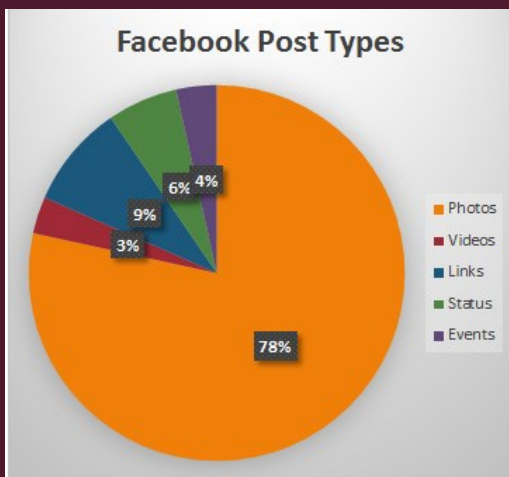

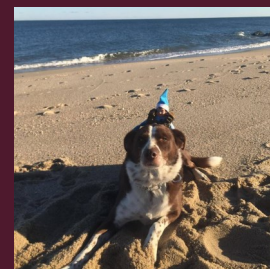
