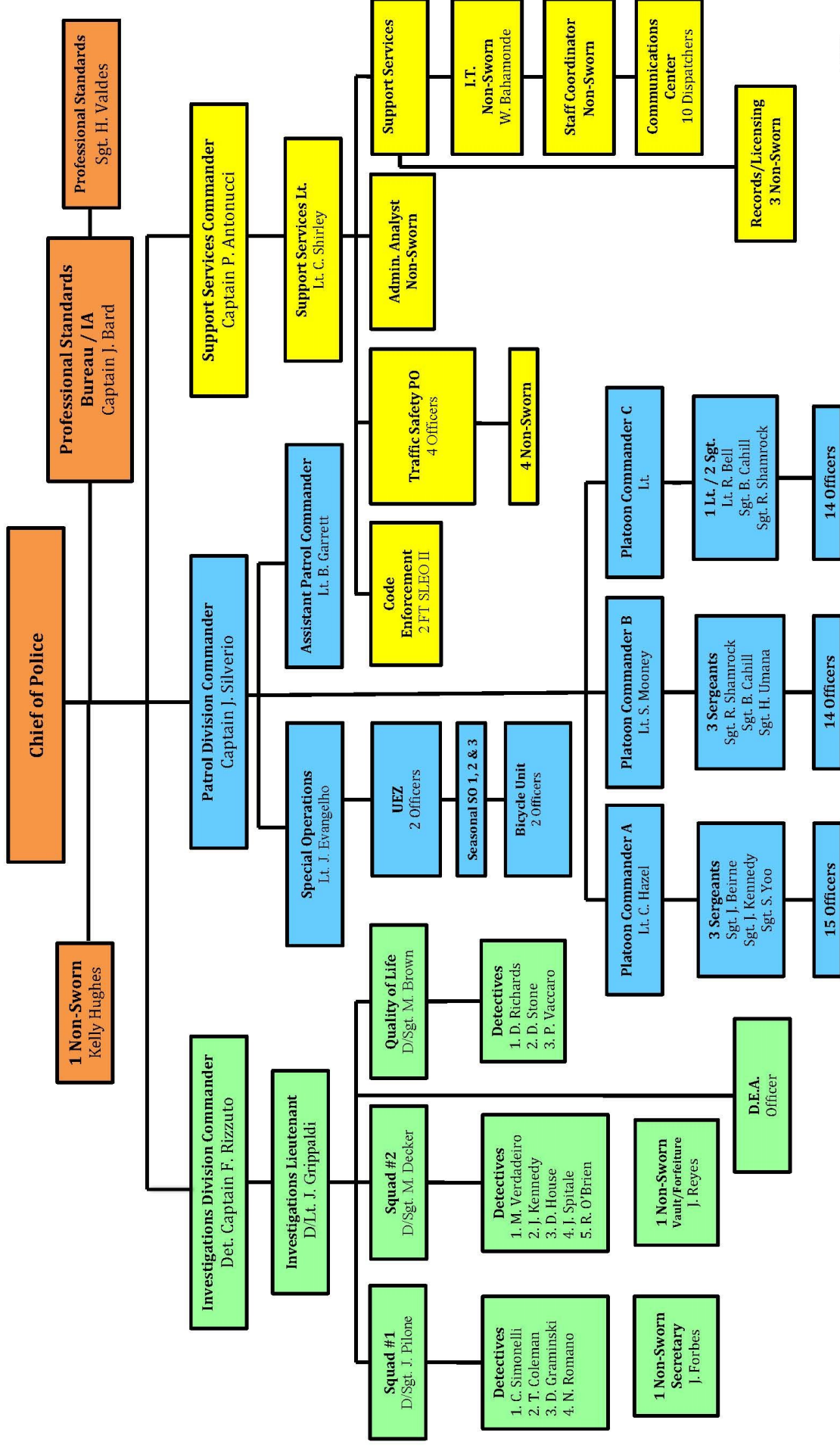

SPECIALIZED UNITS

INVESTIGATIONS BUREAU

The Long Branch Police Department Investigations Division gathers facts for criminal investigations and prosecutions. They compile evidence by observing suspects, interviewing witnesses, and examining physical evidence. The Detectives investigate criminal acts including homicides, sexual assaults, armed robberies, home invasions, and property crimes such as burglaries and arson as well as any unattended deaths. Detectives collect and use forensic evidence to solve crimes, and interview informants, suspects, and witnesses to ascertain alibis, motives, clues, and establish time frames. Detectives spend most of their time gathering facts and evidence for criminal cases they have been assigned. They gather evidence through informants, by interviewing witnesses, and by observing, monitoring, and recording the activities of known or suspected criminals. In performing their duties, it is absolutely necessary that they gain knowledge of suspects and the circumstances surrounding a crime before singling out a perpetrator. Once motives, alibis, past relationships, and the evidence has been determined and analyzed, a detective will interrogate a suspect with the aim of determining their guilt or innocence.

In 2019, a total of 723 cases were investigated by our Detectives.

The Investigations Bureau maintains Units specializing in Major Crimes, Street Crimes, Forensics and Juvenile Matters. Detectives are dedicated to the following areas:

STREET CRIMES UNIT

The Street Crimes Unit is comprised of one Commanding Officer and three Detectives. Their primary focus is to eliminate drug manufacturing and distribution within the City and reduce the availability of narcotics and other illegal substances to our citizens. In addition, they serve as an intelligence bureau for criminals involved with weapons, gangs and other illegal activity.

In 2019, the Street Crimes Unit made 214 arrests, 130 of which were narcotics related offenses. They executed 6 residential search warrants for narcotics and assisted County, State and Federal agencies on 7 search warrants.

Through their investigations and arrests, they seized 2 vehicles for forfeiture, \$9,544 cash and were able to remove 5.15 ounces of cocaine, 618 doses of heroin, 5.44 pounds of marijuana and 89 prescription pills from the streets.

CODE AND FIRE PREVENTION UNIT

Class 2 Special Officers Brian Dinero and Davi Cunha and part-time Class 2 Officers, Christian DeFazio and Robert Piantanida are assigned to the City Code & Fire Prevention Bureau.

Along with responding to calls for service as an auxiliary to police patrol units, their primary duty with code enforcement is to ensure property owners comply with the safety and quality of life ordinances. These including property maintenance, fire code compliance, zoning and building permit compliance, and environmental concerns such as recycling and proper waste disposal.

They inspect for hazards to pedestrian and vehicular traffic such as low wires, dangerous trees, dangerous sidewalks, derelict or vacant homes, abandoned swimming pools and standing water issues for mosquito control. They also investigate illegal rooming houses, unregistered rental properties, conduct inspections for certificate of occupancy compliance, and perform annual "meet and greet" inspections of all off campus housing for Monmouth University to welcome students and insure they comply with local ordinances.

In addition, they set up and maintain the "hot zone" for fireworks displays, respond to any general emergency in the city, cover during states of emergencies and special events, as well as coordinate with other agencies such as the EPA/DEP and utility providers for any issues falling outside the scope of routine enforcement.

ANIMAL CONTROL

Detective David House is the Municipal Humane Law Enforcement Officer (HLEO) for the Long Branch Police Department and Officer Francis Sheldrick is the Assistant HLEO. They are tasked with investigating any severe animal cruelty cases within the city.



All our officers assist the City's Animal Control Bureau on a regular basis responding to calls that involve animals in distress or in need of rescuing. Animal Control calls in the City range from typical dog and cat related issues to seals, squirrels, bats, geese, raccoons, deer and even occasional farm or exotic animals. Our officers have seen it all!

FIREARMS UNIT

Members of the Firearms Unit include Supervising Firearms Instructor Lt. John Evangelho, Instructors Sgt. Sam Yoo, Sgt. Hector Umana, Cpl. Ben Cruz, Cpl. Chris Gant, Det. Rich O'Brien and Cpl. Lance Fanning, who is also the Armorer.

This unit is tasked with the annual firearms training and qualifications of all LBPD Officers as well as maintaining the weapons and ammunition for the department.



MOTORCYCLE UNIT

Our Motorcycle Unit rides year-round, weather permitting. Aside from being a tremendous asset in traffic control, especially during high-congestion events, they frequently assist in motor escorts such as dignitary transports and funeral processions.

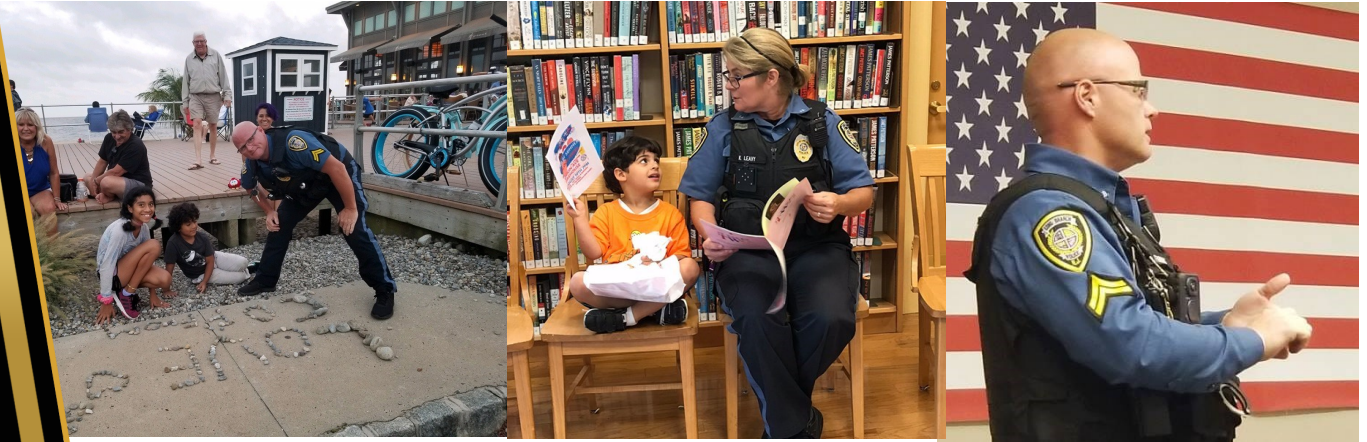

URBAN ENTERPRISE UNIT (UEZ)

The Urban Enterprise Zone (U.E.Z.) focuses on our community in an effort to keep the lines of communication flowing between the police department and the public. Corporals Kimberly Leavy and Lance Fanning work closely with local business owners, students and residents and provide a multitude of events and services throughout the year. A few examples of their programs include school presentations, senior program involvement, City Hall tours for scouts and students, and perhaps the two most popular, National Night Out and the Citizens Police Academy (CPA).



TRAFFIC BUREAU

Our Traffic Bureau consists of four full-time officers, one Special Class 2 and three civilians. Members include Cpl. Cesare Simonelli, Cpl. Benny Cruz, PO Brian Boryszewski, PO Gary Vecchione, SO Kevin Cuje, George Medina, Andrew Clay and Ryan Scanlon. Lt. Charles Shirley, Jr. is the Unit's Supervisor.

While the Unit was originally formed with the goal of maintaining and repairing traffic signals, the responsibilities of its members have grown to include street signage, special events, road crew and new construction traffic plans, vehicle upgrades and the installation and maintenance of equipment within our vehicles. With ever changing technology, these members are constantly being trained to work on new equipment.

Scanlon, our newest member brings an extensive skill set to the unit as he is certified in areas such as programming and installation of police radios, emergency lights, surveillance cameras, body worn cameras and digital mobile video recorders (DMVR).

HONOR GUARD

Our Honor Guard serves a number of official functions such as swearing-ins, promotions, parades and funerals and its members participate on a voluntary basis.

2019 members consisted of Sgt. Hector Umana, Cpl. Lance Fanning, Cpl. KiJung Kim, Det. Daniel Richards, Det. Brian Oliveira, PO Jesus Otero, PO Gary Vecchione and PO Brian Boryszewski.

In addition to in-house functions, they proudly presented the colors at several sporting events in 2019 including:

- January 14th-NJ Devils Game at Prudential Center
- September 29-NY Red Bulls game at Red Bull Arena
- December 3rd-NJ Devils game at Prudential Center

A large group of supporters made up of friends and family of the Long Branch Police Department accompanied the Honor Guard to the January 14th NJ Devils Game. All attendees enjoyed a game of Broom Ball on the ice after the game.



K9 UNIT

The City of Long Branch Police Canine (K9) Unit is made up of two teams, Sgt. Robert Shamrock and K9 Hagan and P.O. Omar Akel and K9 Hades. These teams respond when patrol requests help in cases that involve expertise in areas such as tracking a suspect and locating narcotics.

In addition to responding to official service calls, our K9 Unit plays a vital role in our community outreach efforts, participating in numerous demonstrations for our public schools, Citizens Police Academies, National Night Out, and many other events.



MOCERT

K9 Team Officer Omar Akel and Hades have been members of the Monmouth County Emergency Response Team (MOCERT) since September of 2018.

MOCERT is operated by the County Prosecutor's Office and integrates tactically trained officers from numerous municipal police departments to form one team. All members have received advanced training in various fields which include but are not limited to Special Weapons And Tactics, high-risk warrant service, hostage rescue, barricaded suspects, active shooters and dignitary protection. Recent team training has included preparation for weapons of mass destruction and terrorism incidents. The team has trained with FBI SWAT and LAPD SWAT as well as instructors from various military and private organizations.

Members train as a team bi-monthly as well as for several full weeks throughout the year. Officers are on call 24 hours a day and 7 days a week. Semi-annually members undergo rigorous physical tests to remain on the team. In addition, members of the team must maintain the rank of firearms expert through firearms qualification scores."



MONMOUTH COUNTY SERIOUS COLLISION ANALYSIS RESPONSE TEAM (SCART)



Officer Brian Boryszewski, a member of our Traffic Bureau continues to serve as a member of the Monmouth County Serious Collision Analysis Response Team (SCART) since the fall of 2018.

He is on call one week a month and responds to any fatal or serious bodily injury motor vehicle accident in Monmouth County during that timeframe.

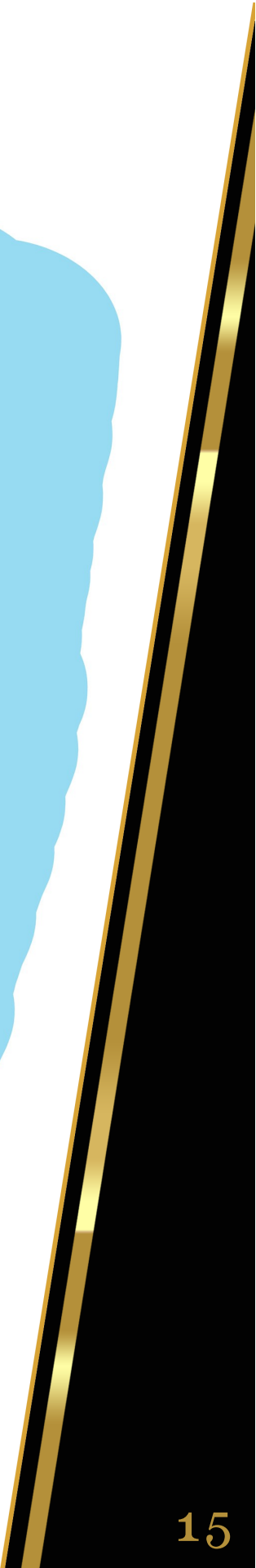
DRUG ENFORCEMENT ADMINISTRATION (DEA)

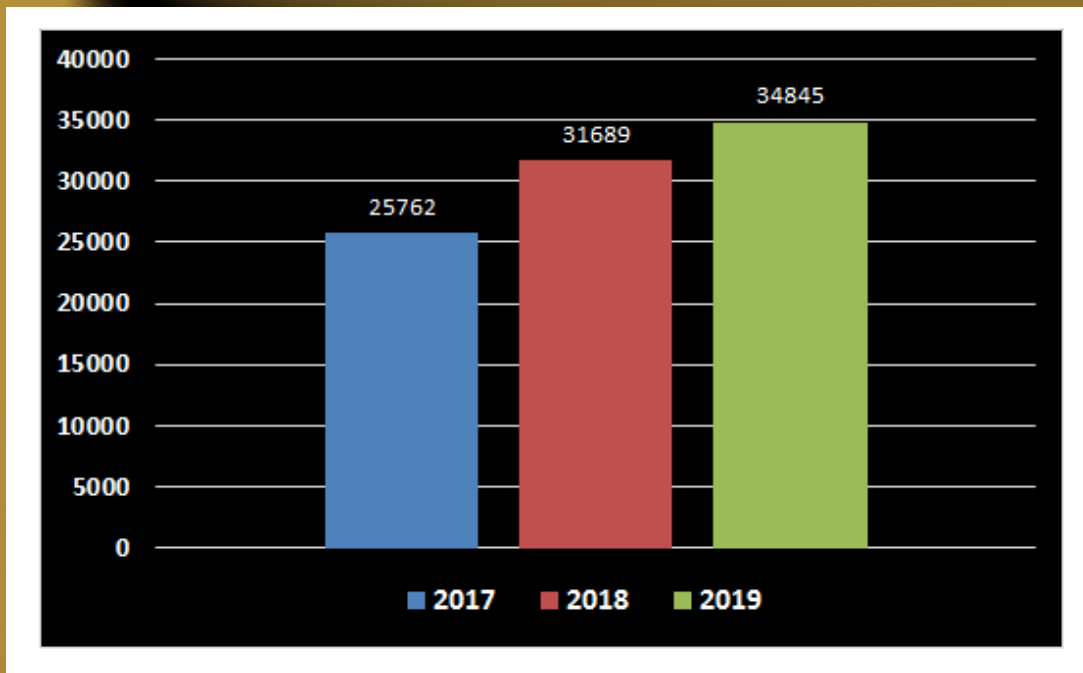
During his time so far, as a Deputized Task Force Officer, he conducted and assisted in numerous narcotics investigations throughout the state of New Jersey, which have led to the arrests of multiple subjects involved in the illegal trafficking of controlled dangerous substances. He participated in numerous search warrant executions, in which large sums of narcotics, money, and weapons were seized, including multi-kilo seizures of Fentanyl.



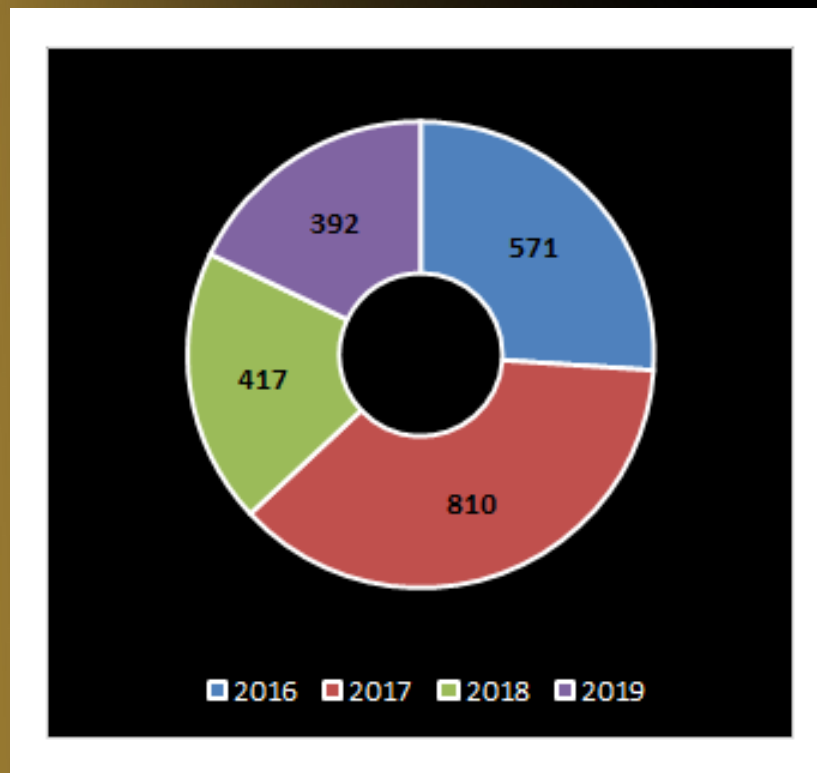

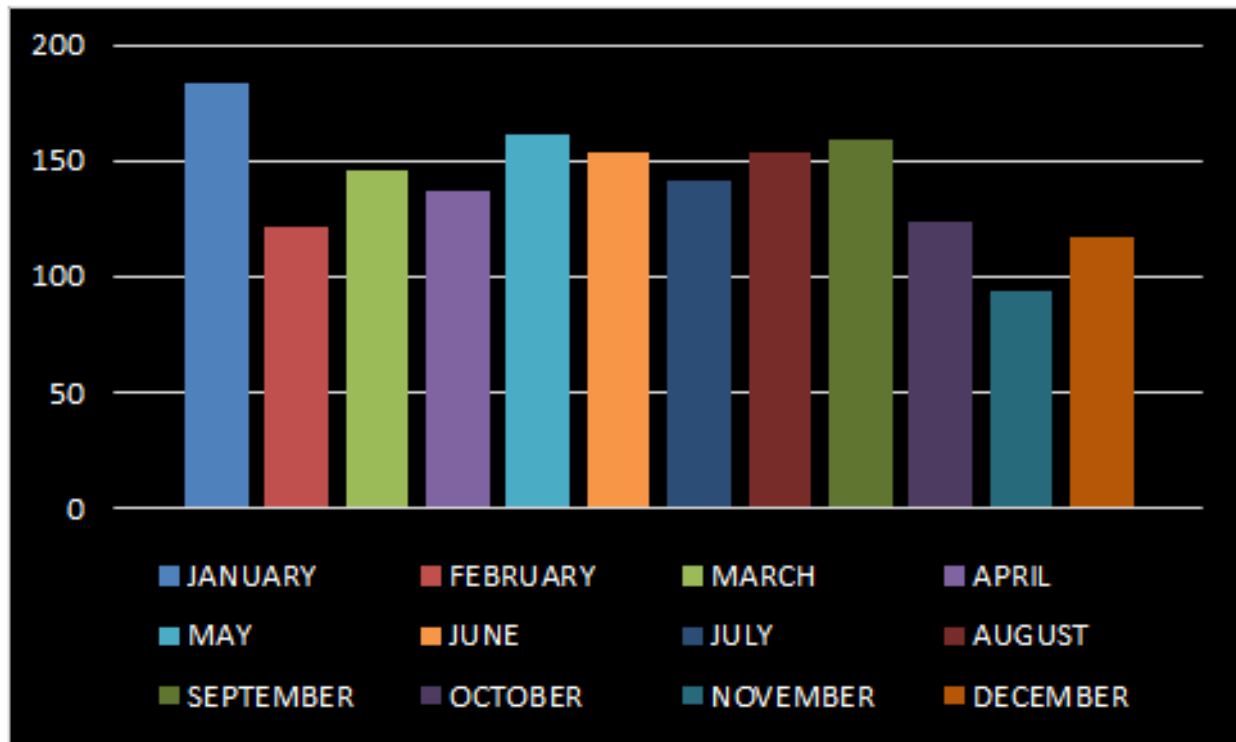
CALLS FOR SERVICE



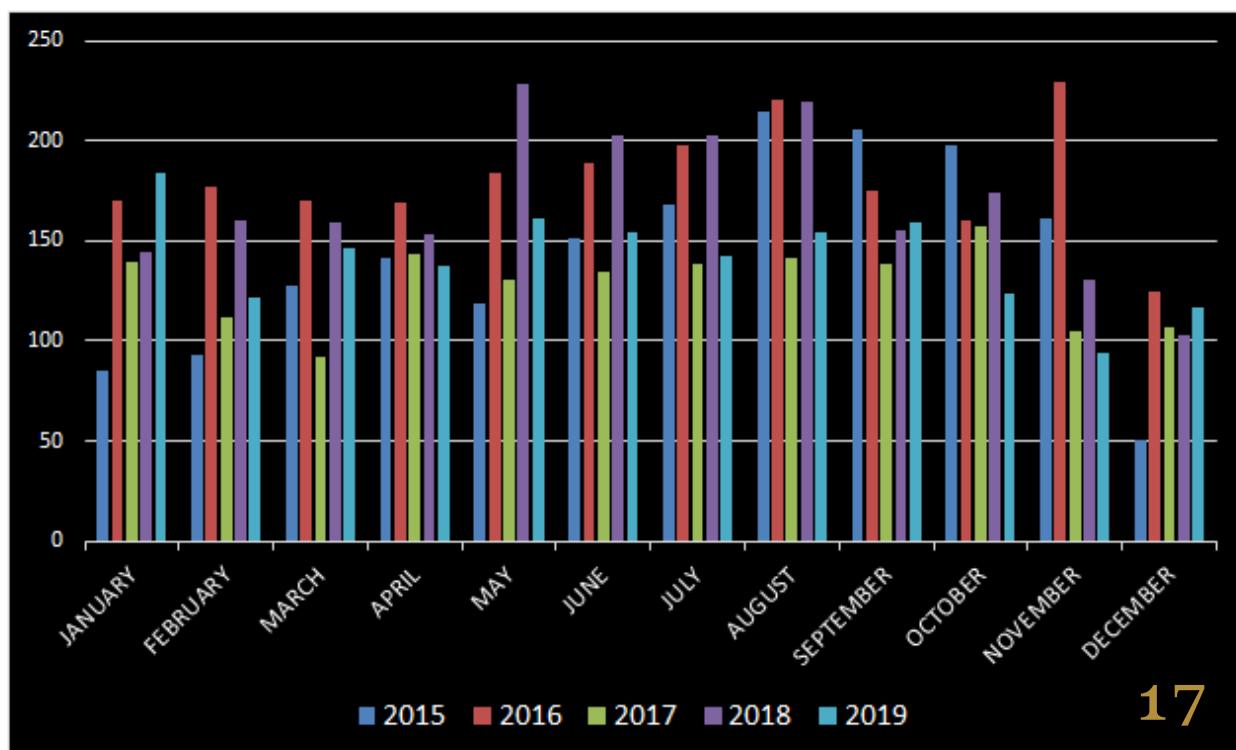
9-1-1 CALLS



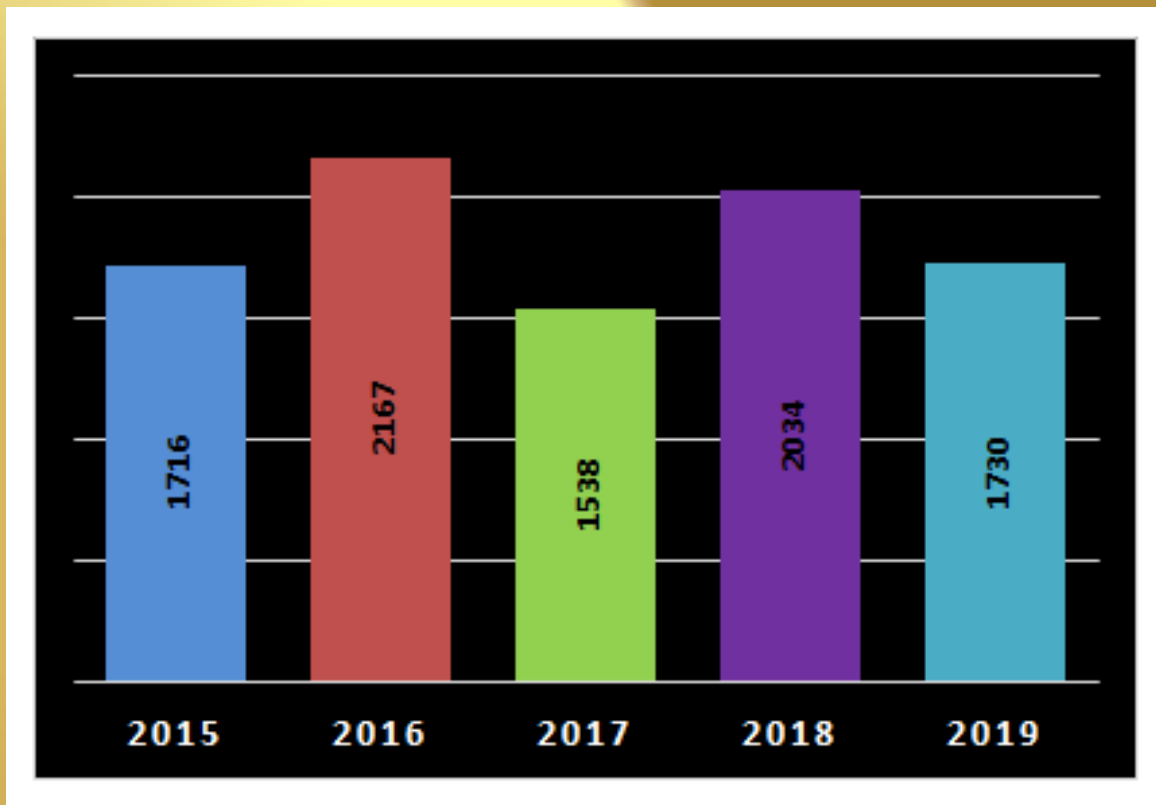
2019 ARRESTS BY MONTH



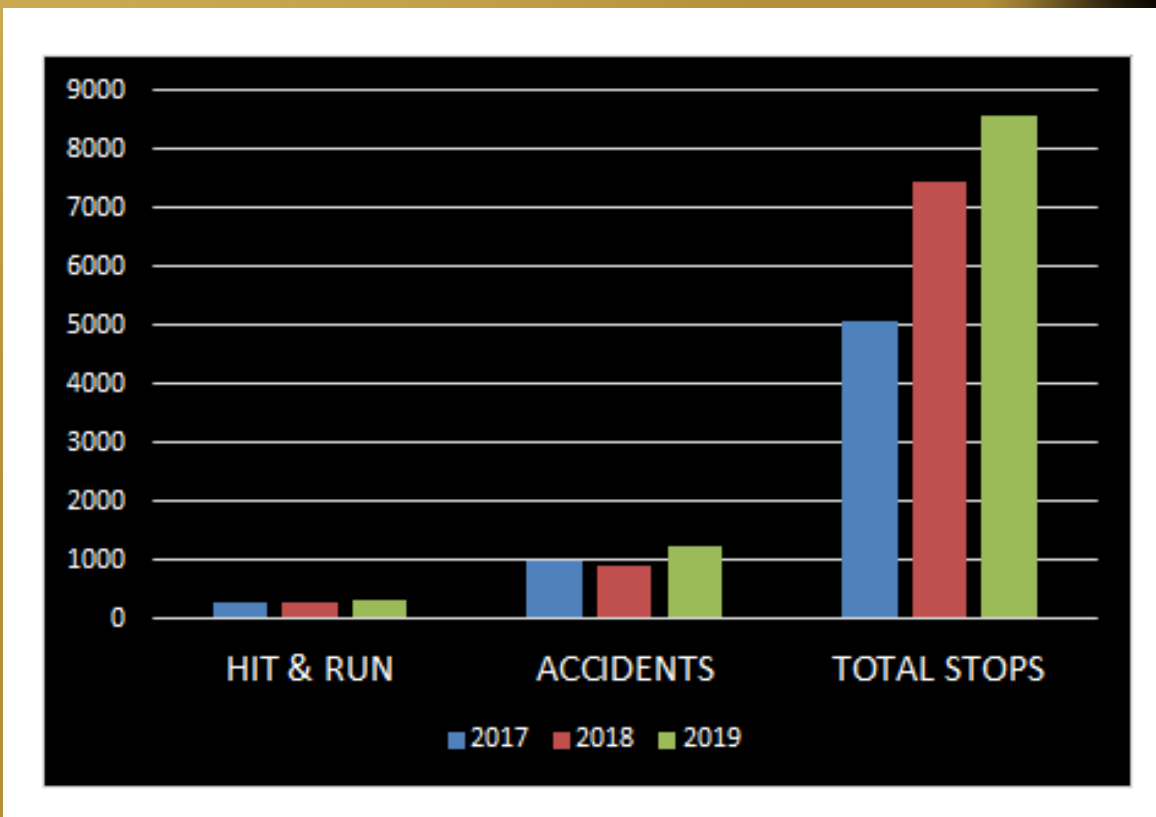
ARRESTS BY MONTH 2015-2019



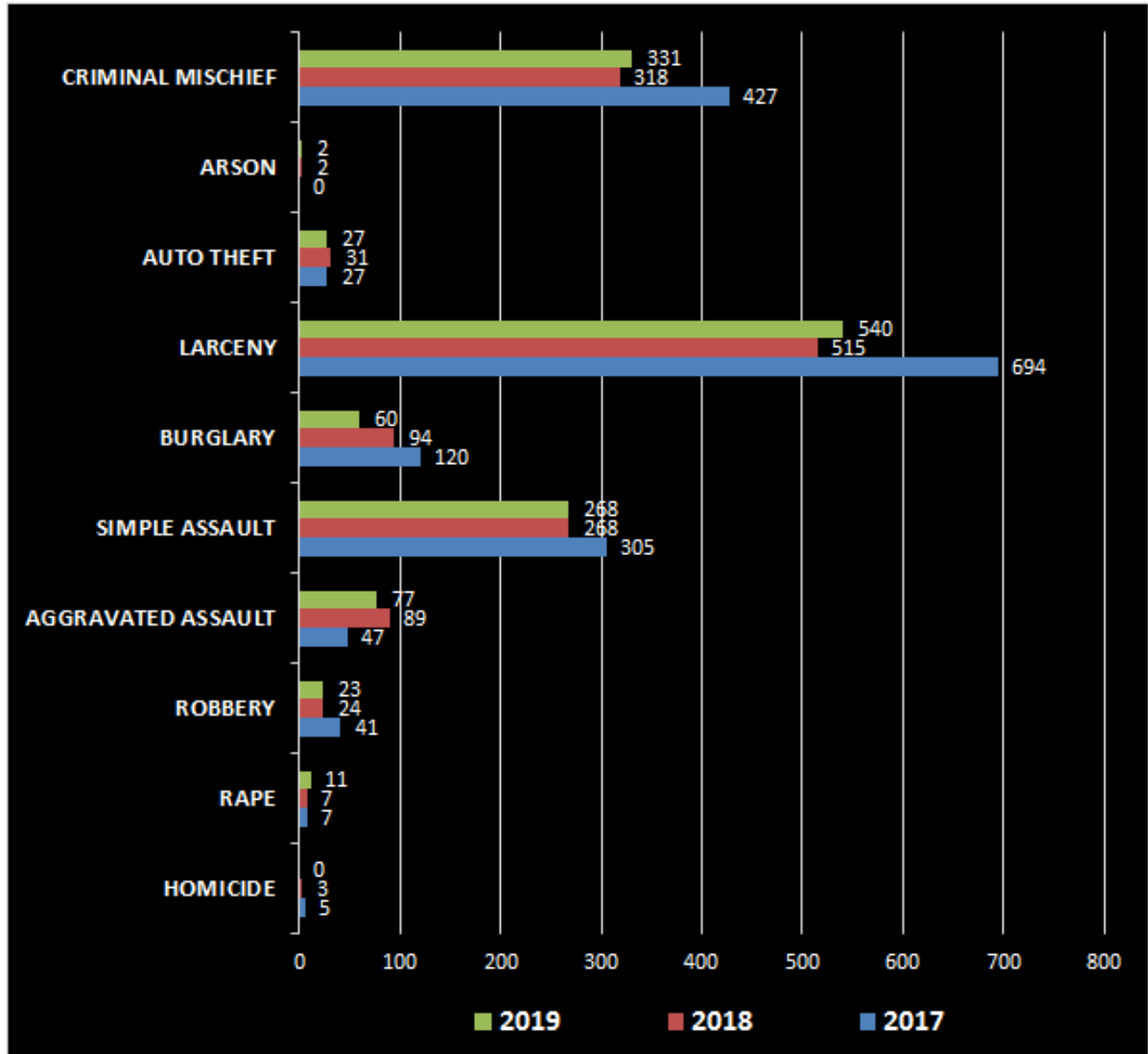
TOTAL ARRESTS BY YEAR



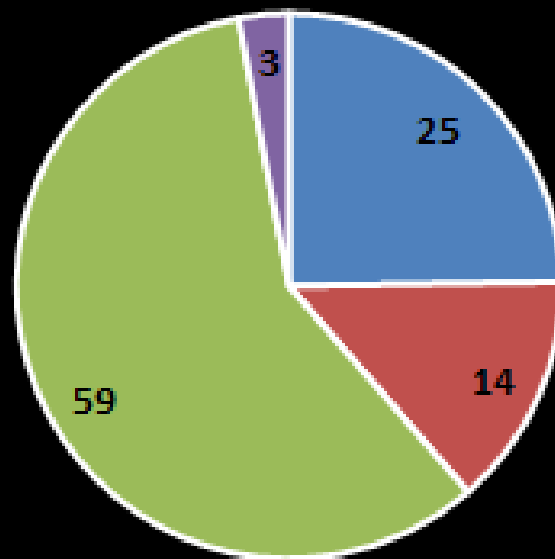
MOTOR VEHICLE STOPS

USE OF FORCE REPORTING

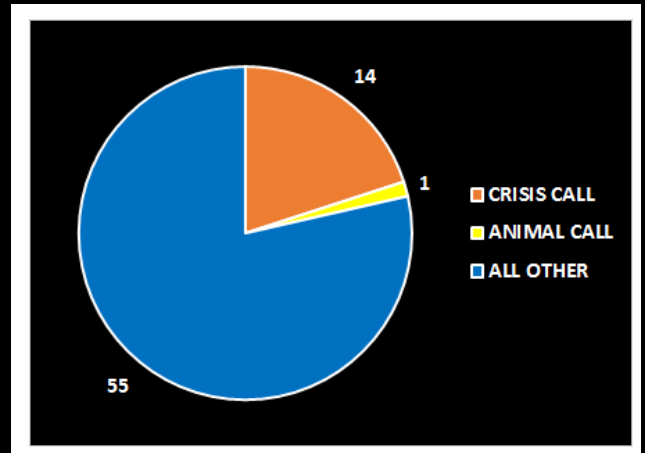
Attorney General (AG) Guidelines require that all law enforcement officers who have responded to a call where physical force is utilized must complete a Use of Force report.

The AG's office defines physical force as follows:

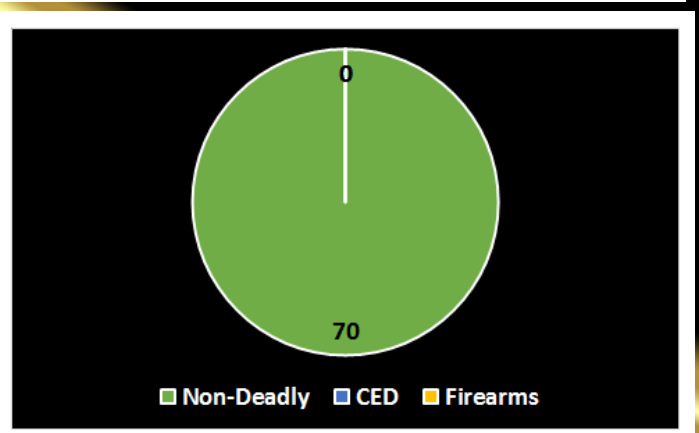
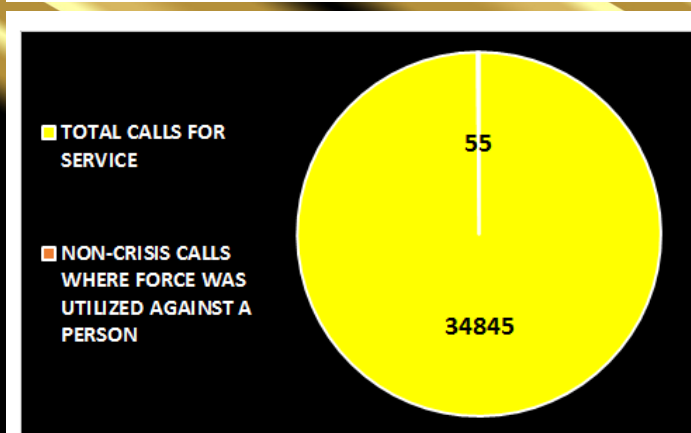
"Physical force involves contact with a subject beyond which is generally utilized to effect an arrest or other law enforcement objective. Physical force is employed when necessary to overcome a subject's physical resistance to the exertion of the law enforcement officer's authority , or to protect persons or property.

Examples include wrestling a resisting subject to the ground, using wrist locks or arm locks, striking with the hands or feet, or other similar methods of hand-to-hand confrontation."

TRAINING

All Officers are required to attend in-service training sessions to stay up-to-date on current laws, professional guidelines, operations and procedures. Some of the training is department specific, while much of it is mandated by the county prosecutor, Attorney General and by state or federal statutes. Most mandated training is required every six months to one year. A few topics covered in the training are firearms requalification, domestic violence, blood-borne pathogens, hazardous materials and breathalyzer recertification.

Specialized units conduct job-specific training and qualification sessions and officers are assigned to attend other agency training courses as needed. The list on the following page shows just a fraction of the training courses that our officers attended in 2019. On average, nearly 400 training orders are issued to individual Officers per year.

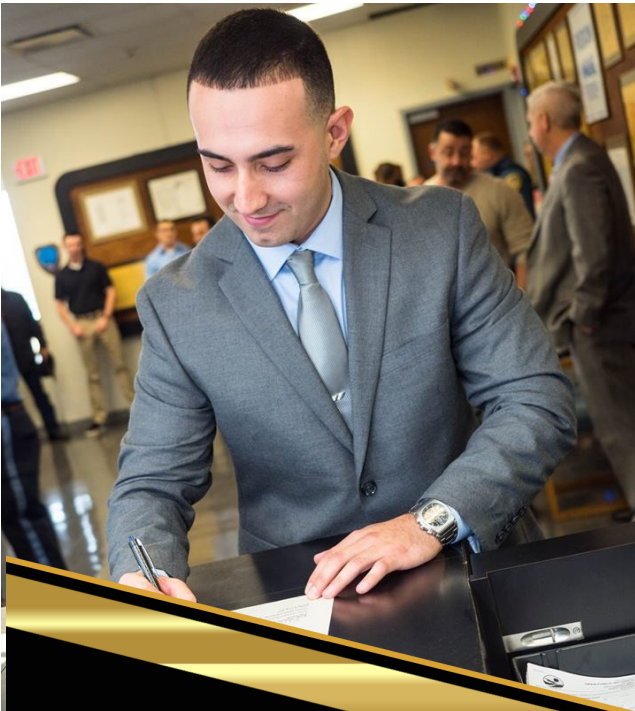

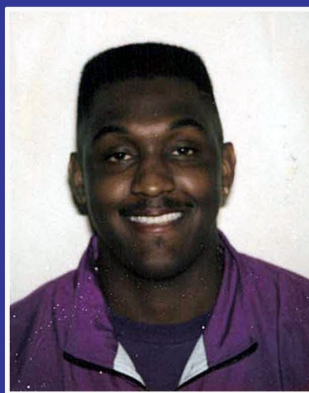

Furthermore, it allowed them time to decide and arrange to donate her organs which helped 8 other people, including 2 babies. She is still in contact with the girl's parents to this day.
- During a first aid call, Cpl. Gant performed CPR on a mother of four who was 8 months pregnant at the time. Not only did her actions save the life of both the mother and unborn child, but Cpl. Gant visited with the family & children on a regular basis while the mother underwent an extensive hospital stay. As a sign of gratitude, they named their daughter Piper Jennifer and continue their relationship to this day.

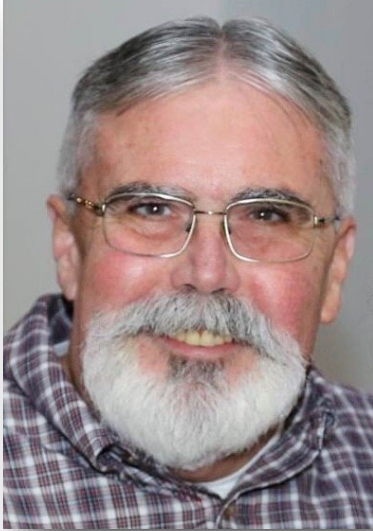

2/6/19 (MCPO): Man Arrested for Long Branch Stabbing

A man has been arrested in connection with a stabbing Tuesday morning in Long Branch, announced Monmouth County Prosecutor Christopher J. Gramiccioni.

Michael Smith, 43, of Brick, is charged with first degree Attempted Murder, two counts of second degree Unlawful Possession of a Weapon, and two counts of second degree Possession of a Weapon for an Unlawful Purpose, in connection with the stabbing of a 34-year old Brick Township woman.

A joint investigation by the Monmouth County Prosecutor's Office and the Long Branch Police Department revealed that on February 5, 2019, at approximately 9:39 a.m., Long Branch Police Officer Robert Korn responded to a stabbing incident. When Officer Korn arrived, he observed the suspect, Michael Smith, swinging and grabbing at the victim, who was lying on the ground. Korn was able to pull Smith off of the victim and place him under arrest. Smith was armed with two knives during the assault and had stabbed the victim multiple times in the chest and head. The victim was taken to the hospital where she is listed in stable condition.

If convicted of Attempted Murder, Smith faces 20 years in a New Jersey state prison without parole. Both the Murder and Attempted Murder charges are subject to the provisions of the "No Early Release Act" (NERA) requiring him to serve 85 percent of the sentence imposed before becoming eligible for release on parole. He would also be under parole supervision for five years following his release from state prison.

If convicted of the second degree weapons offenses, Smith faces a sentence up to ten years in prison on each charge.

Smith is scheduled to have his First Appearance on February 11, 2019 in Superior Court with a Detention Hearing to immediately follow.

The case is assigned to Monmouth County Assistant Prosecutor Stephanie Dugan.

Despite these charges, every defendant is presumed innocent, unless and until found guilty beyond a reasonable doubt, following a trial at which the defendant has all of the trial rights guaranteed by the U.S. Constitution and State law.

2/25/19 (LBPD): Three Officers Injured in Vehicle Pursuit

Three Long Branch Police Officers were injured earlier this evening following a motor vehicle accident during a vehicle pursuit. Two Detectives were treated and released from Monmouth Medical Center, and the other officer is being held for observation overnight at Jersey Shore Medical Center.

The pursuit started as a result of a drug investigation, further details will be released when the investigation is completed. The suspect's vehicle was located, the three suspects in the car fled the scene after the accident. We have no reason to believe there is any danger to the public, or that the suspects are still in the area. A complete search of the surrounding area was conducted.

Please keep the officers in your thoughts as they recover from their injuries. Thank you.

Long Branch Police Department Launches Addiction Intervention Team

Chief Jason Roebuck and the Long Branch Police Department (LBPD) have taken a tremendous step in the war on substance abuse. The LBPD has recently partnered with Coming Full Circle (CFC) Loud N Clear Foundation and will adopt the R.I.S.E. (Recovery, Intervention, Support, and Education) Crisis Intervention Team. The R.I.S.E. program was created by CFC Loud N Clear Foundation in collaboration with Chief Andrew Kudrick of the Howell Police Department in 2016. The R.I.S.E. Crisis Intervention Team has provided a dedicated CFC emergency hotline number to the LBPD and will provide 24 hour on-call services to for the purpose of responding to substance abuse related calls. CFC members will provide peer support and multiple resources to individuals involved in such cases as well as engage with their family members for optimum positive outcomes. In addition, CFC will assist in finding and encouraging treatment resources, follow up on progress for a six month period, document outcomes and provide LBPD with updated status information.

Drug overdoses kill more than 64,000 people per year, and the nation's life expectancy has fallen for two years in a row. Mental Health issues such as depression, anxiety, and bipolar disorder are on the rise. Children of addicts are 8x more likely to develop an addiction. Siblings of addicts are 4x more likely. Families with addicted spouses are 80% more likely to end up divorced. Ultimately, our community suffers when substance abuse is prevalent.

3/25/19 (LBPD): Arrest made in vehicle pursuit

An arrest has been made in a vehicle pursuit that left three Long Branch Police Officers injured during a serious motor vehicle accident. The pursuit and subsequent accident occurred February 25th, 2019 at approximately 6:35 pm. Michael A. Priester was arrested on March 7th, 2019 for his role in the incident.

The vehicle pursuit which began on Morris Avenue, Long Branch, stemmed from a narcotics distribution investigation. The pursuit was terminated after an officer involved accident occurred at the intersection of Ocean Avenue and South Lake Drive. A marked patrol unit and an unmarked detective vehicle collided, causing extensive damage to both vehicles. Officer Joshua Wagner was transported to Jersey Shore University Medical Center, where he was treated and hospitalized for several days. He is still recuperating from his injuries and not yet able to return to duty. Detectives Patrick Vaccaro and Daniel Richards were treated and released at Monmouth Medical Center and returned to duty that evening.

The accused vehicle was also damaged in the pursuit and found abandoned a few blocks from the accident. A search was conducted in the area, but the occupants had fled the scene. Detectives continued with the investigation in the ensuing weeks and were able to issue warrants for Priester, 24 years old, whose last known address is Neptune, NJ. He was arrested for:

Resisting Arrest, Eluding in a Motor Vehicle-2nd degree crime.

Conspiracy to Distribute Controlled Dangerous Substance (CDS) within 500 feet of a park – 2nd degree crime

Conspiracy to Distribute Controlled Dangerous Substance (CDS) within 1000 feet of a school- 3rd degree crime

Chief Roebuck stated, "Remember, it's the accused that decides to initiate the pursuit by failing to stop for the police. The Long Branch Police Department was not going to rest until the person responsible for placing our residents and officers in danger was identified and apprehended. Vehicle pursuits are inherently dangerous, but as in this case sometimes our officers have no choice but to pursue a dangerous criminal. The Long Branch Police will continue to vigilantly enforce the law while remembering that the safety of the public and our officers are of utmost importance."

Vehicle Pursuits are governed by the Attorney General's Guidelines, and specifically state when officers can initiate and continue pursuits. These guidelines were followed. The pursuit is being reviewed by the Monmouth County Prosecutor's Office.

3/29/19 (MCPO): Fatal fire in Long Branch on Friday, March 29, 2019.

At approximately 2:07 a.m., Long Branch Police Department received multiple calls of a structure fire at 135 Charles St. Heavy fire activity was noted at the time of arrival. One resident was located inside, the victim, Thomas Booth III, 67, who was removed from the residence by Long Branch PD. CPR was initiated by on scene and Booth was transported to Jersey Shore University Medical Center. The victim was pronounced at 3:15 a.m. A post-mortem exam is scheduled for later today. Fire suppression efforts were conducted by the Long Branch Fire Department with assistance from Neptune Fire Department. The fire was deemed under control at 2:34 a.m. Long Branch, Elberon and Monmouth Beach First Aid Squads all responded to assist. No further injuries were reported.

4/15/19 (MCPO): Man Sentenced to Life in Prison Without Parole for 2013 Double Murder

Carlos I. Menjivar, 26, of 45 North Fifth Ave. in Long Branch, was sentenced on Friday to life in prison without the possibility of parole for the 2013 double murder of a couple found dead inside a Sairs Avenue apartment, announced Monmouth County Prosecutor Christopher J. Gramiccioni.

Monmouth County Presiding Criminal Judge David F. Bauman sentenced Menjivar to life imprisonment without the possibility of parole for the murder of Maria Yolanda Catejo-Munoz, 35, and a consecutive term of life imprisonment for the murder of Fredis Orlando Ventura, 33, both of Long Branch.

During the sentencing, Judge Bauman highlighted the brutal nature of these killings, stating that “the defendant did not simply murder the victims, he butchered them.”

Menjivar was previously found guilty of two counts of first-degree murder, and one count of third-degree Possession of a Weapon for an Unlawful Purpose, and one count of fourth-degree Unlawful Possession of a Weapon on December 18, 2018 following a two-month jury trial presided over by Judge Bauman.

Menjivar was arrested following a joint investigation by the Monmouth County Prosecutor's Office Major Crimes Bureau, Long Branch Police Department and Monmouth County Sheriff's Office. The investigation began after Catejo-Munoz was reported missing around noon on Sunday, March 24, prompting a search for her whereabouts. The search led Long Branch Police to the Sairs Avenue apartment of Ventura, who had been romantically involved with Catejo-Munoz. At around 4 p.m. on March 25, 2013, both victims were discovered dead inside the apartment with multiple stab wounds.

Evidence presented at the trial revealed that Ventura invited Menjivar, a third man and Catejo-Munoz to his residence in the early morning hours of Mar. 24, 2013. After the third man had left the apartment, Menjivar fatally stabbed the two victims.

During the investigation, police learned Menjivar had been in possession of a knife while inside Ventura's apartment and had asked the other man there not to tell the police about the knife. Approximately 21 months later, on Dec. 16, 2014, Menjivar admitted to detectives that he stabbed Ventura in the neck with a knife, but claimed he had been forced to do so by others who had also killed Catejo-Munoz. DNA, forensic evidence located at the crime scene and his own phone records disproved Menjivar's version of events.

The case was prosecuted by Monmouth County Assistant Prosecutors Paul Alexander and Ian D. Brater.

Menjivar is represented by Allison Friedman, Esq., and Lisa Maglone, Esq., both of Freehold.

Great work by lead Detective Todd Coleman, the entire detective bureau and all LBPD officers involved in this investigation.

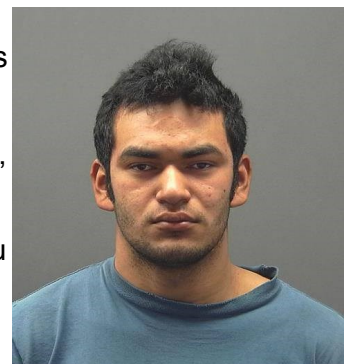

5/1/19 (LBPD): Check Well Being Incident

6/10/19 (LBPD): Two Arrests Made in Attempted Burglary After Foot Pursuit

On June 10, 2019, at approximately 0100, PO Garcia was in the area of 164 Broadway monitoring vehicle and pedestrian traffic from his patrol vehicle. He observed two male juveniles attempt to enter several vehicles parked on Second Avenue. Upon observing the attempted burglary, he attempted to stop the accused parties. Both juveniles ignored PO Garcia's commands to stop and fled on foot through nearby residential backyards. PO Garcia chased both on foot and provided detailed information to dispatch on the descriptions of the suspects. Dispatch, along with the supervisors, relayed the information quickly and accurately and helped coordinate a great effort. The majority of units on shift assisted by immediately setting up a perimeter. One suspect was taken into custody quickly. The second suspect was hiding in brush close by. A K9 was requested through the county radio room and Sgt. McGrogan (Middletown PD) and his K9 partner, Jax responded to the scene to assist.

The officers on scene, with the assistance of the Sgt. McGrogan and K9 Jax were able to take the second suspect into custody approximately one hour after the initial foot pursuit started. The officers on scene had all received minor injuries during the incident as they had checked locations with briars and thorns yet remained on scene until the second suspect could be located in the thick brush. Their dedication to duty is second to none and should be recognized for their tenacity in seeing the second suspect was brought to justice.

7/2/19 (MCPO): Long Branch Man Gets 30-Year Prison Term for 2017 Shooting

A Long Branch man was sentenced to 30 years in prison for the 2017 shooting death of another city man, announced Monmouth County Prosecutor Christopher J. Gramiccioni.

Jeffrey Williams, 31, was convicted by a jury on October 4, 2018, of a range of charges including first degree Felony Murder, second degree Reckless Manslaughter, second degree Possession of a Weapon for an Unlawful Purpose and second degree Unlawful Possession of a Weapon following a four-week trial before Monmouth County Superior Court Judge Vincent N. Falcetano.

At trial, testimony revealed that on Sunday night, July 16, 2017, Williams and several others were hanging out near the corner of Central Avenue and Liberty Street in Long Branch when they realized that there was an older Hispanic male asleep on the front porch of 111-2 Liberty Street. Armed with this information, defendant and at least 2 others approached the man. While one of the men was attempting to take property from the victim, the man awoke and reacted to their presence. In response, Jeffrey Williams pulled out a handgun and shot the man. Approximately 20 minutes later, the victim's estranged wife came home to find her husband dead on the porch and called 911. She told police Hector Mejia had come over in order to drop off money for her and their kids.

Williams was arrested on July 20, 2017, and charged in connection with the death of 47-year-old Hector C. Mejia, who was found bleeding with a gunshot wound near the front door of his Liberty Street home. Long Branch Police Department responded to an 11:41 p.m. 911 call on July 16, 2017, reporting the shooting. Police and medical personnel responded to the location and the victim was pronounced deceased at 11:56 p.m. A joint investigation by the Monmouth County Prosecutor's Office and Long Branch Police Department led to the arrest of Williams four days later.

The case was prosecuted by Assistant Prosecutor Christopher J. Decker, Director of the Office's Major Crimes Bureau and Assistant Prosecutor Nicole Wallace.

Williams was represented by Carlos Diaz-Cobo, Esq. of New Brunswick and James Greenberg, Esq. of Freehold.

7/15/19 (LBPD): Police Vehicle Struck by Train

This morning at approximately 10:53 am one of our officers was backing up another officer on a motor vehicle stop on Brighton Avenue. When he exited the vehicle to assist the primary officer, his vehicle began to roll forward, unnoticed. The officer reported after the fact that he remembered having trouble getting it into park, but felt that he did before he exited the vehicle.

It rolled down a small grass embankment and came to stop with the front end extended slightly onto the railroad tracks., As luck would have it, a train was coming and struck the police car. Fortunately, no one was injured, except for some feelings. NJ Transit Police are in charge of the investigation.

7/20/19 (LBPD): Scammers Posing as Members of the Long Branch Police Department

On Monday, July 15th, a report was taken from a local female regarding a fraudulent call that showed up on caller ID as Long Branch Police Department (732-222-1000). The male caller claimed to be a member of the LBPD and told her he was conducting an investigation with the Social Security Administration because someone had used her social security number and racked up \$1.6 billion dollars in debt in her name. The caller began demanding her personal information including her social security number, and information for all of her checking, saving, credit and gift card accounts. When the victim was reluctant to give out her information, he threatened her with an arrest. Thankfully, the victim of this fraudulent call was smart, did not provide personal/account information and immediately responded to headquarters to make a report.

Our Investigation Bureau has confirmed that the caller utilized technology to make the call appear as if it was coming from the Long Branch Police Department. BE AWARE OF THIS SCAM AND DO NOT PROVIDE ANY PERSONAL INFORMATION OVER THE PHONE! You WILL NOT be asked for any personal account information from any Long Branch Police officer or Social Security Administration representative via phone...EVER! Personal information such as that should only be shared face-to-face or via postal mail from an official agency.

7/22/19 (LBPD): Vandalism in West End Park

On July 20th 2019, around 7:30pm, an officer was dispatched to the West End Park for a report of vandalism. The officer then received information that a concerned citizen notified the police department regarding swastikas that had been drawn in several locations throughout the park.

An investigation revealed that six swastikas were drawn, three on a vinyl fence, and three on park equipment. They were approximately two to three inches tall and written in what appeared to be permanent marker.

A Forensic Detective was called to the scene to conduct further investigation. The scene was processed, and the Long Branch Department of Public Works responded, removing all traces of the vandalism.

Mayor Pallone stated, "I am very upset to find out about the recent vandalism at the West End Park. When first hearing about this incident, I immediately went to the scene and was deeply disturbed by the hateful markings displayed in our park. This anti-Semitism and racial prejudice have no place in our society or in the City of Long Branch. We will not stand for this."

The Monmouth County Prosecutors Office has been notified, and the investigation is being conducted following bias incident protocols. Patrol Checks have been increased in the area. At this point in the investigation there is nothing to indicate that this is anything more than a random act of vandalism, but we encourage the public to remain vigilant and report any suspicious activity immediately.

9/10/19 (LBPD): Swift Arrest Made in House Burglary

On September 5, 2019 at approximately 12:02 AM, Corporal Stan Eskridge was dispatched to Brighton Avenue for a Burglary which just occurred to the residence. Corporal Eskridge met with resident upon arrival. Sergeant Hector Umana arrived on scene and translated Portuguese to English for him. The victim said a male possibly Brazilian or Portuguese, wearing a blue Barcelona soccer jersey with "Neymar" written on the back of the jersey, broke into his residence. He further described the accused as approximately 5 foot 9 inches tall, light skinned, short black hair with unshaven facial hair, and stated the accused left on a bicycle east on Brighton Avenue. Corporal Eskridge remained on scene to obtain additional information.

Corporal Kijung Kim responded to the area and began to canvas the area for anyone matching the description of the possible accused. Corporal Kim observed a subject riding a bicycle eastbound on Brighton Avenue wearing a "Neymar Jr" soccer jersey. The subject turned to Corporal Kim at which time, Corporal Kim was able to see it was a male with short dark hair, unshaven wearing a blue jersey. Corporal Kim conducted an interview with the subject later identified as Marcos Cota-Caetano. At this time a Show Up Identification Procedure was completed, and the victim identified Marcos Cota-Caetano as the person who entered his house.

The Long Branch Detective Bureau was contacted, and Forensic Detective Robert Poss arrived at the residence to process the scene. Detective Poss photographed the scene which depicted the accused entered the residence through the east side of the first-floor window. The accused used a 5-gallon bucket to stand up to the elevated window to the bathroom. The accused left a partial boot print in the dirt next to the bucket which was photographed. The accused then entered the master bedroom and took change from an empty water jug and aluminum can of coins.

Marco Cota-Caetano was placed under arrest and transported to Police Headquarters for booking and processing. Marco Cota-Caetano was charged with Burglary to Structure and Theft of Property. Cota-Caetano was interviewed by Detective Michael Verdadeiro and Detective Joseph Spitale. Cota-Caetano gave a confession to Detective Verdadeiro in Portuguese that he had entered the residence.

Great job by all the officers and Detectives involved!

AWARDS



On the afternoon of August 21st, 2018, Officer George Samol was flagged down on Broadway by an individual who had just witnessed a murder inside a restaurant. Officer Samol called for backup, drew his service weapon and entered the building to assist with an on-going struggle between the suspect and a Good Samaritan over possession of a firearm. Once inside, the suspect, who had just been disarmed by the other individual, attempted to take possession of Samol's weapon and a violent struggle ensued. Corporal Tracey Widdis was the first backup officer on scene and arriving at a pivotal moment in the struggle. Utilizing her asp, she was able to help Samol fend the suspect off and maintain control of his weapon until additional officers arrived to assist in subduing him. The swift actions of these officers prevented any further injury or loss of life to the additional civilians in the restaurant at the time, including a few who were also being targeted by the suspect.

For their bravery and heroic actions in this case, these officers were recognized throughout the year with following prestigious honors:

- Officer George Samol was named Police Officer of the year on April 13, 2019 by the Long Branch Elks Lodge # 742
- Officer George Samol & Corporal Tracey Widdis were presented Meritorious Service Awards at the April 17th Monmouth and Ocean County Intelligence Bureau (M.O.C.I.B.) Valor Awards Luncheon!
- Officer George Samol was one of only six Monmouth County Officers to be awarded the Valor Award on June 7th, the highest award given, by the 200 Club of Monmouth County.
- Officer George Samol and Corporal Tracey Widdis, received the Valor Award at the New Jersey State Association of Chiefs of Police annual installation dinner on June 26th. The Valor Award is the NJSACOP's highest award, given to those Police Officers who have demonstrated exceptional heroism and dedication to their agency and the public. They were the only two officers in the State of NJ to receive this prestigious award this year.
- Officer George Samol and Corporal Tracey Widdis were honored with a Meritorious Service Valor Award at the New Jersey State Policemen's Benevolent Association's annual Valor Awards Banquet in Atlantic City on November 23, 2019.





On the afternoon of February 5, 2019 Officer Robert Korn responded to a domestic incident involving a subject actively attempting to murder his wife. Without hesitation or regard for his own safety, he pulled the subject away from the victim, ensured he was disarmed and placed him under arrest. His swift response allowed other officers to administer first aid to the victim and undoubtedly helped to save her life.

For his bravery and heroic actions in this case, he was presented by the LBPB with the Meritorious Service Award at the November 13th Council Meeting. Corporal Korn was again honored at the New Jersey State Policemen's Benevolent Association's annual Valor Awards Banquet in Atlantic City on November 23, 2019 with the Meritorious Service Valor Award .

Sergeant James Beirne was selected by the New Jersey Narcotic Enforcement Officers Association (NJNEOA) as this year's recipient of an Individual Guns, Gangs & Narcotics Law Enforcement Award. Sgt. Beirne was recognized for his role in the investigation, led by the Monmouth County Prosecutor's Office Narcotics and Criminal Enterprise Investigation Section, dubbed "Operation Undertow". The Awards Ceremony took place during their Annual Luncheon, which was held in Atlantic City on June 13th.

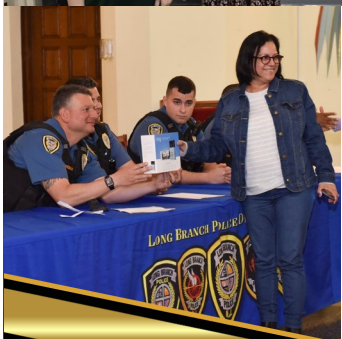

In addition, we will be sharing public safety information via posts to the public and, on occasion, we will send out requests to camera owners to share video with us that could assist in an investigation. Our detectives are excited to utilize this new tool as a means to partner with and receive assistance from our community members in solving their cases.
